## AN ORDINANCE

AUTHORIZING THE FOLLOWING CONTRACTS ESTABLISHING UNIT PRICES FOR GOODS AND SERVICES FOR AN ESTIMATED ANNUAL COST OF \$2,034,000.00: (A) T & W TIRE FOR EMERGENCY TIRES, (B) **ESTRADA** LANDSCAPE, DUE AMICIS, INC. D/B/A **GREEN** LANDSCAPING AND GOODWILL INDUSTRIES OF SAN ANTONIO FOR LAWN MAINTENANCE FOR DOWNTOWN LOCATIONS, PARKS, AND TRAILHEADS, (C) CLIENTRACK, INC. FOR CLIENTRACK FOR THE DEPARTMENT OF HUMAN SERVICES, (D) INNOVATIVE INTERFACES, INC. FOR MILLENNIUM SOFTWARE MAINTENANCE & SUPPORT, (E) ZOLL MEDICAL CORPORATION FOR X SERIES EQUIPMENT AND SUPPLIES FOR THE FIRE DEPARTMENT AND (F) BOUND TREE MEDICAL, LLC AND ZOLL MEDICAL CORPORATION FOR X SERIES SUPPLIES FOR THE FIRE DEPARTMENT.

WHEREAS, the City is able to obtain significant savings by purchasing various materials and services on an annual contract basis; and

WHEREAS, these bids are from the following companies to furnish the City with (A) T & W Tire for emergency tires, (B) Estrada Landscape, Due Amicis, Inc. d/b/a Green Landscaping and Goodwill Industries of San Antonio for lawn maintenance for downtown locations, parks, and trailheads, (C) ClienTrack, Inc. for ClienTrack for the Department of Human Services, (D) Innovative Interfaces, Inc. for millennium software maintenance & support, (E) ZOLL Medical Corporation for X Series equipment and supplies for the Fire Department and (F) Bound Tree Medical, LLC and ZOLL Medical Corporation for X Series supplies for the Fire Department; and

**WHEREAS**, the bid submitted by Bound Tree Medical LLC for Items 1a and 1j failed to meet the City's specifications and/or requirements; and

**WHEREAS,** this ordinance approves 3 low bid contracts, 3 sole source contracts, 1 contract procured using a purchasing cooperative, and 2 contracts procured on the basis of public health or safety exemption; and

**WHEREAS**, all expenditures will be in accordance with the applicable fiscal year's budget approved by City Council; **NOW THEREFORE**:

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

**SECTION 1.** The bids from the following companies to furnish the City with (A) T & W Tire for emergency tires, (B) Estrada Landscape, Due Amicis, Inc. d/b/a Green Landscaping and Goodwill Industries of San Antonio for lawn maintenance for downtown locations, parks, and trailheads, (C) ClienTrack, Inc. for ClienTrack for the Department of Human Services, (D) Innovative Interfaces, Inc. for millennium software maintenance & support, (E) ZOLL Medical Corporation for X Series equipment and supplies for the Fire Department and (F) Bound Tree Medical, LLC and ZOLL Medical Corporation for X Series supplies for the Fire Department on an annual contract basis as shown on the attached bid tabulation sheets, are hereby accepted, subject to and contingent upon the deposit of all required bonds, performance deposits, insurance certificates and endorsements. The bid tabulation sheets are attached hereto and incorporated herein for all purposes as **Exhibit I**. Copies of the bids are available for inspection in the offices of the Purchasing Division of the Finance Department.

**SECTION 2.** It has been found and declared that the bid submitted by Bound Tree Medical, LLC for Items 1a and 1j failed to meet the City's specifications and/or requirements.

**SECTION 3.** The amounts will be encumbered upon issuance of various purchase orders, and payment is authorized to the vendors identified herein. All current fiscal year expenditures will be in accordance with the Fiscal Year 2014 budget approved by City Council, and future fiscal year expenditures are contingent upon future City Council budget approvals.

**SECTION 4.** This ordinance is effective immediately upon passage by eight affirmative votes; otherwise it is effective on the tenth day after passage hereof.
