

AN ORDINANCE 2017-10-19-0817

SECTION 1. The previously scheduled City Council meetings are rescheduled as follows, to accommodate the National League of Cities Conference and the City's Winter Break:




SECTION 2. All Council Committee meetings previously scheduled for the dates above may be rescheduled to the corresponding weeks, as noted in the chart.
