**APPOINTING JULIAN DAIS, NADIA ISLAM, SYDNEY KNOWLES,  
CRISTINA VILLEGAS-HERNANDEZ AND FRED WILLIAMS TO THE  
CITIZENS ADVISORY ACTION BOARD FOR TWO-YEAR TERMS OF  
OFFICE, TO EXPIRE ON DECEMBER 2, 2022.**

**WHEREAS**, pursuant to the provisions of Section 3 of Article 29 of the Collective Bargaining Agreement between the City of San Antonio, Texas and the San Antonio Police Officers' Association, passed and approved by San Antonio City Council on September 1, 2016, the San Antonio City Council must select persons from a list of applicants provided by the City Manager to serve as members of the Citizen Advisory Action Board (CAAB); and

**WHEREAS**, there are currently five vacancies on the CAAB, which is composed of fourteen persons, and which hears investigations on complaints made against police officers for misconduct, use of force and violation of the San Antonio Police Department General Manual; and

**WHEREAS**, the term of appointments on the CAAB will be for a two-year period, to expire on December 2, 2022; and

**WHEREAS**, applicants were interviewed by a three-person panel, which consisted of Deputy City Manager Maria Villagómez, Chief of Police William McManus and First Assistant City Attorney Elizabeth Provencio, and the City Manager and Chief of Police recommend each of the persons listed in Section 1 of this Ordinance; and

**WHEREAS**, the list of recommended appointees is representative of the diversity of the community, and

**WHEREAS**, input and recommendation of the San Antonio Police Officers' Association shall be obtained as to the recommended appointees; and

**WHEREAS**, those on said list must meet the minimum qualifications established by Subsection 143.006(c) of the Texas Local Government Code for service on the San Antonio Fire Fighters' and Police Officers' Civil Service Commission; and

**WHEREAS**, the City Manager submitted such a list and all of those on that list meet the minimum qualifications; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**


**SECTION 1.** The following persons are hereby selected and appointed to serve as members on the CAAB:

2. Nadia Islam
3. Sydney Knowles
4. Cristina Villegas-Hernandez
5. Fred Williams

**SECTION 2.** The service of said members on the CAAB shall be for a term of two years, to expire on December 2, 2022.

**SECTION 3.** This ordinance shall be effective immediately upon passage by eight affirmative votes; otherwise it shall be effective on the tenth day after passage hereof.
