WHEREAS, Ordinance No. 2014-06-19-0469, passed and approved on June 19, 2014, approved a fixed rate loan for the Cevallos Lofts Apartment project in an amount not to exceed \$3,200,000.00; and

WHEREAS, after said Ordinance was passed and approved, Cevallos Lofts Ltd. was required to pay down their Texas Department of Housing and Community Affairs (TDHCA) loan by \$500,000.00; and

WHEREAS, TDHCA requirement necessitates an increase in the fixed rate loan to an amount not to exceed \$3,700,000.00; and

WHEREAS, it is necessary for the City Council to amend Ordinance No. 2014-06-19-0469 to increase the fixed rate loan for the Cevallos Lofts Apartment project; NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. Ordinance No. 2014-06-19-0469 is hereby amended to increase the fixed rate loan for the Cevallos Lofts Apartment project to an amount not to exceed \$3,700,000.00.

SECTION 2. This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
