

AN ORDINANCE 2014 - 10 - 09 - 0777

**AUTHORIZING THE SUBMISSION OF A GRANT APPLICATION TO
KABOOM! AND THE ACCEPTANCE UPON AWARD OF A NEW
PLAYSCAPE, AT AN ESTIMATED VALUE OF \$80,000.00, FOR
THUNDERBIRD HILLS PARK LOCATED IN COUNCIL DISTRICT 7.**

WHEREAS, KaBoom! is a national non-profit organization that envisions a great place to play within walking distance of every child in America; and

WHEREAS, since 1995, KaBoom! has used its community-build model to bring together business and community interests to construct playgrounds; and

WHEREAS, KaBoom! selects sites based on a number of factors such as if existing playgrounds are within the vicinity, neighborhoods with engaged parents and families and a viable non-profit to serve as the community partner for the project; and

WHEREAS, Thunderbird Hills Park was acquired in 2013 and does not have an existing playground; and

WHEREAS, the playground would complement the planned trail, pavilion, and parking lot improvements; and

WHEREAS, based on the KaBoom! criteria and decisive factors of their funding partner, Thunderbird Hills Park is recommended for application and meets their preliminary review prior to commitment; and

WHEREAS, this action authorizes the grant application submission and acceptance upon award; and

WHEREAS, the KaBoom! grant process requires volunteers to install the playground equipment; and

WHEREAS, volunteers will be engaged throughout the process of designing the playscape until the build days, which is scheduled by KaBoom!; and

WHEREAS, the grant process requires community partners to combine with the City for the playground build projects; and

WHEREAS, Thunderbird Hills Homeowners Association is the community partner and will assist with volunteer recruitment and other aspects of the playground build at Thunderbird Hills Park;
NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or her designee or the Director of the Parks and Recreation Department or his designee, is authorized to submit a grant application to KaBoom! and to accept upon award a new playscape, at an estimated value of \$80,000.00, for Thunderbird Hills Park located in Council District 7. A copy of the application is on file with the Parks and Recreation Department.

SECTION 2. The City Manager or her designee or the Director of the Parks and Recreation Department or his designee, is further authorized to execute any and all necessary documents to effectuate the submission of the grant application and said acceptance of funds.

SECTION 3. The donation of property and/or services to the City of San Antonio must comply with GASB 33 and AD 8.8. All necessary information must be coordinated through the City's Finance Department to assure the recording of the proper accounting transactions.

SECTION 4. Funding in the amount of \$8,500.00 for this ordinance is available for Fund 11001000, Cost Center 2615010002 and General Ledger 5304070, as part of the Fiscal Year 2015 Budget.

SECTION 5. Payment not to exceed the budgeted amount is authorized to KaBoom! and should be encumbered with a purchase order.

SECTION 6. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 7. This ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.


