

AN ORDINANCE 2014 - 12 - 11 - 1026

**AUTHORIZING THE RENAMING OF ALTA VISTA STREET TO
“JAIME P. MARTINEZ PLACE” BETWEEN THE CROSS
STREETS OF SOUTH NAVIDAD STREET AND SOUTH TRINITY
STREET IN CITY COUNCIL DISTRICT 5, SAN ANTONIO,
TEXAS.**

WHEREAS, the Development Services Department received a City Council Request (CCR) from Councilwoman Gonzalez to rename Alta Vista Street between the cross streets of South Navidad Street and South Trinity Street as “Jaime P. Martinez Place” to honor his lifetime of achievement in community service and to recognize him as founder and President of the Cesar E. Chavez LULAC Council No. 4626 in San Antonio, Texas and founder of the Cesar E. Chavez March for Justice; and

WHEREAS, the Development Services Department staff was tasked with implementing this request through the street renaming process as required by Chapter 6 of the City Code; and

WHEREAS, this request was forwarded to and reviewed by all City of San Antonio departments and outside agencies and no opposition was identified; and

WHEREAS, staff conducted a technical review finding it to conform to City Code requirements for renaming of public streets; and

WHEREAS, notice of this request to rename said street was properly posted and mailed to affected property owners, notice requirements for renaming of the street has been satisfied in accordance with Chapter 6 of the City Code and further, no written opposition has been received to the name change from affected property owners; and

WHEREAS, public hearing was held for the Planning Commission on December 3, 2014 allowing all interested persons to be heard; Historic Design Review Commission considered the request on December 3, 2014; and

WHEREAS, both the Planning Commission and the Historic Design Review Commission (HDRC) approved motions to support the street name to “Jaime P. Martinez Place;” **NOW THEREFORE**,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:


SECTION 1. The public alley known as Alta Vista Street located in City Council District 5 between the cross streets of South Navidad Street and South Trinity Street is hereby named Jaime P. Martinez Place. The location is more specifically depicted in **Attachment 1**. City staff is directed to provide appropriate signage detailing “Jaime P Martinez Pl.”

SECTION 2. Funds generated by this ordinance will be deposited into Fund 11001000, Internal Order 223000000167 and General Ledger 6301120.

SECTION 3. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 4. This ordinance is effective immediately upon receipt of eight affirmative votes; otherwise, it is effective 10 days after passage.


