

AN ORDINANCE 2015-06-04-0480

**ACCEPTING THE LOWEST RESPONSIVE BID AND AWARDING A CONSTRUCTION CONTRACT IN THE AMOUNT NOT TO EXCEED \$1,799,179.62 TO CRG, FOR THE PEGGY DRIVE EXTENSION PROJECT, A 2012-2017 BOND FUNDED PROJECT, LOCATED IN COUNCIL DISTRICT 2.**

**WHEREAS**, the 2012-2017 Bond Program authorized \$5,600,000.00 for the Peggy Drive Extension Project, and of this amount \$1,799,179.62 will be used for construction with the balance of the Project funds to be used for design services, environmental services, advertising, property acquisition and project management; and

**WHEREAS** this Project provides for a new 30-foot roadway of approximately 0.30 miles in length to connect the Eastgate subdivision to Houston Street and to include a new span bridge, the addition of 4-foot sidewalks, curbs, driveway approaches and drainage improvements throughout the Project limits; and

**WHEREAS**, this Ordinance accepts the lowest responsive bid submitted by **CRG** in the amount not to exceed \$1,799,179.62 for the Peggy Drive Extension Project, and

**WHEREAS**, this is a one-time capital improvement expenditure in the amount of \$1,799,179.62 for which funds are available from the 2012-2017 General Obligations Bonds and are included in the FY 2015 - 2020 Capital Improvements Program Budget; **NOW THEREFORE**,

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The lowest responsive bid of **CRG** in the amount not to exceed \$1,799,179.62 for the Peggy Drive Extension Project is hereby accepted. All other bids will be considered rejected upon the execution of a contract by the successful bidder and the deposit of all required bonds and insurance certificates or the expiration of ninety (90) days from the effective date hereof, whichever occurs first.

**SECTION 2.** A construction contract is hereby awarded to **CRG**.

**SECTION 3.** The following financial adjustments are hereby approved:

- a) Payment in the amount not to exceed \$1,799,179.62 in SAP Fund 45099000, General Obligation Capital Projects, SAP Project Definition 40-00310, Peggy Drive Extension, is authorized to be encumbered and made payable to **CRG**, for construction services.

- b) The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

**SECTION 4.** This Ordinance shall be effective immediately upon passage by eight or more affirmative votes; otherwise, it shall be effective on the tenth day after passage.
