

**AMENDMENT #1  
TO DELEGATE AGENCY CONTRACT  
WITH  
FAMILY SERVICE ASSOCIATION OF SAN ANTONIO, INC.**

This amendment (“Amendment”) to the Delegate Agency Contract (“Contract”) for various projects is entered into by and between the City of San Antonio, a Texas Municipal Corporation, (hereinafter referred to as “City”) acting by and through its designated representative, the Director of the Department of Human Services, pursuant to Ordinance No. \_\_\_\_\_ passed and approved on \_\_\_\_\_, and the Family Service Association of San Antonio, Inc. (hereinafter referred to as “Contractor”).

WHEREAS, the City presently contracts with Contractor pursuant to a Delegate Agency Contract executed on November 6, 2014 pursuant to Ordinance No. 2014-09-18-0690; and

WHEREAS, the parties desire to amend the Contract to allocate an additional \$78,660.00 in funds to the Youth College and Career Readiness project; and

WHEREAS, it is in the best interest of the City that an amendment of the Contract now be executed which revises the Contractor’s budget for the Youth College and Career Readiness project; NOWHEREFORE:

City and District agree to amend the Agreement as follows:

1. Section 3.1 shall read as follows:

In consideration, the City will reimburse Contractor for costs incurred for each of the Projects listed above in accordance with the budget approved for each Project by City Council of San Antonio in the above referenced Ordinance, and all subsequently authorized amendments to the respective budgets. Said budgets are affixed hereto and incorporated herein for all purposes as **Attachment A – II** for Project A, **Attachment B – II** for Project B, **Attachment C – II** for Project C, and **Attachment D – II** for Project D. It is specifically agreed that reimbursement hereunder shall not exceed the combined total amount of **\$617,924.00**, broken down as follows:

\$ 221,255.00 for the Family Strengthening and Kindergarten Readiness (Project A); and  
\$ 15,000.00 for VITA Free Tax Preparation and Asset Building (Project B); and  
\$ 272,508.00 for Youth College and Career Opportunities (Project C); and  
\$ 109,161.00 for Youth Against Gang Activity (Project D).

2. Section 3.2 shall read as follows:

The funding level of this Contract is based on an allocation from the following funding sources:

\$ 617,924.00 General Fund

Consequently, Contractor agrees to comply with the **Funding Guide**, affixed hereto and incorporated herein for all purposes as **Attachment III**.

3. The document attached hereto and incorporated herein as **Exhibit I** reflects agreed upon budget revisions to **Attachment C – II**, the budget for Project C in the Contract. The revisions supersede prior conflicting or inconsistent agreements with regard to the referenced project budget, and all references in the Contract to the budget for Project C (Attachment C – II) shall mean the budget as revised by this Amendment.
  
4. The document attached hereto and incorporated herein as **Exhibit II** reflects agreed upon revisions to **Attachment I**, the Scope of Work and SA2020 Scorecard, in the Contract. The revisions supersede prior conflicting or inconsistent agreements with regard to the referenced Scope of Work and SA 2020 Scorecard, and all references in the Contract to the Scope of Work and SA 2020 Scorecard shall mean the Attachment I as revised by this Amendment
  
5. All other terms, conditions, covenants and provisions of the Contract are hereby continued and shall remain in effect in their original form, except for the provisions modified by this Amendment.
