**AN ORDINANCE**

**AUTHORIZING ACCEPTANCE OF A PROPOSAL FROM SCHINDLER ELEVATOR CORPORATION TO PROVIDE THE SAN ANTONIO AIRPORT SYSTEM WITH ELEVATOR AND ESCALATOR MAINTENANCE AND REPAIRS FOR A TOTAL ESTIMATED ANNUAL COST OF \$1,600,000.00, FUNDED FROM THE AVIATION OPERATIONS AND MAINTENANCE FUND.**

**WHEREAS**, the City released a Request for Competitive Sealed Proposals (RFCSP) to provide the City with elevator and escalator preventive maintenance, repair, and clean down services; and

**WHEREAS**, three responses were received and evaluated; and

**WHEREAS**, staff recommends Schindler Elevator Corp. for award of this contract; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The proposal submitted by Schindler Elevator Corp. to provide the City with elevator and escalator preventive maintenance, repair, and clean down services is hereby accepted, subject to and contingent upon the deposit of all required bonds, performance deposits, insurance certificates and endorsements. A copy of the score summary and RFCSP are attached hereto and incorporated herein for all purposes as **Exhibit A**.

**SECTION 2.** Funding for this ordinance in the amount of \$1,600,000.00 is available in Fund 51001000, Cost Center 3305030006 and General Ledger 5204050 as part of the Fiscal Year 2018 Budget. Additional funding for this ordinance is contingent upon City Council approval of the City's operating budget and the availability of funds for subsequent Fiscal Years.

**SECTION 3.** Payment not to exceed the budgeted amount is authorized to Schindler Elevator Corp. and should be encumbered with a purchase order.

**SECTION 4.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.
