AN ORDINANCE 2016 - 01 - 28 - 0053

AMENDING THE OFFICIAL ZONING MAP OF THE CITY OF SAN ANTONIO BY AMENDING CHAPTER 35, UNIFIED DEVELOPMENT CODE, SECTION 35-304, OF THE CITY CODE OF SAN ANTONIO, TEXAS BY CHANGING THE ZONING DISTRICT BOUNDARY OF CERTAIN PROPERTY.

WHEREAS, a public hearing was held after notice and publication regarding this amendment to the Official Zoning Map at which time parties in interest and citizens were given an opportunity to be heard; and

WHEREAS, the Zoning Commission has submitted a final report to the City Council regarding this amendment to the Official Zoning Map of the City of San Antonio; NOW THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. Chapter 35, Unified Development Code, Section 35-304, Official Zoning Map, of the City Code of San Antonio, Texas is amended by changing the zoning district boundary of 0.826 acre out of NCB 7582 from "MF-33 AHOD" Multi-Family Airport Hazard Overlay District to "C-2 AHOD" Commercial Airport Hazard Overlay District.

SECTION 2. A description of the property is attached as **Attachment "A"** and made a part hereof and incorporated herein for all purposes.

SECTION 3. All other provisions of Chapter 35 except those expressly amended by this ordinance shall remain in full force and effect including the penalties for violations as made and provided for in Section 35-491.

SECTION 4. The Director of Development Services shall change the zoning records and maps in accordance with this ordinance and the same shall be available and open to the public for inspection.

SECTION 5. This ordinance shall become effective February 7, 2016.



BEGINNING: At a set 1/2" iron pin, said pin being the southeast intersection of S. New Braunfels Avenue and Betty Jean and being the Point of Beginning;

THENCE: Along the south right-of-way line of Betty Jean, N89°24'16'E, a distance of 86.23 feet to a found ½ iron pin for an angle point and being the northeast corner of this tract;

THENCE Departing the south right-of-way line of Betty Jean, S00°35'44"E, a distance of 145.00 feet to a set ½" iron pin for an angle;

THENCE: N89°24'16"E, a distance of 77.70 feet to a set ½" iron pin for an angle point;

THENCE: S00°35'44"E, a distance of 135.34 feet to a found ½" iron pin for an angle point, said point being the southeast corner of this tract;

THENCE: S89°12'26"W, a distance of 172.86 feet to a set ½" iron pin for an angle point, said point being along the east right-of-way line of S. New Braunfels Avenue and the southwest corner of this tract;

THENCE: Along the east right-of-way line of S. New Braunfels Avenue, N01°13'33"E, a distance of 281.08 feet to the Point of Beginning and containing 0.826 acres of land.
