

AN ORDINANCE 2014 - 09 - 04 - 0643

AWARDING A CONSTRUCTION CONTRACT TO WALTON ENTERPRISES, LTD. DBA WALTON SIGNAGE IN THE AMOUNT NOT TO EXCEED \$370,453.00 FOR THE PARKING TRAILBLAZING SIGNAGE SYSTEM PROJECT, A PARKING IMPROVEMENT AND CONTINGENCY FUND PROJECT, LOCATED IN COUNCIL DISTRICT 1.

WHEREAS, the Downtown Trailblazing Parking Master Plan was a recommendation of the San Antonio Downtown Parking Study, which developed a set of goals and objectives the parking system would achieve to promote downtown economic development and enhanced customer service; and

WHEREAS, the first two (2) components of the Master Plan have been completed and the Project is in its final phase of the 2008 Downtown Trailblazing Parking Master Plan; and

WHEREAS, the intent of the Master Plan design is to upgrade the existing off-street parking revenue control system, on-street parking meters system and prepare a trailblazing master plan, in support of all downtown parking facilities; and

WHEREAS, the parking revenue control system and meters portion of the plan have been completed and the remaining component of the Master Plan is the Trailblazing Signage portion to be completed by August 2015; and

WHEREAS, the Project provides for the manufacture, supply and installation of 116 traffic directional signs to four (4) garages located on St. Mary's Street, Convention Center, Central Library and Houston Street which will receive garage name signs that will be illuminated as well as certain entry and exit signs, other parking and pedestrian directional signs consisting of Directory Maps Signs, Entry/Exit Signs and Roadway/Ramp Parking Guide Signs; and

WHEREAS, surface or street-mounted signs will incorporate a new concept in post detail with a square post with a black powder coating finial cap; and

WHEREAS, five City-owned and operated parking lots that are included in this Project are located at Dolorosa, City Hall Annex, IH-35, East Houston Street and the Convention Center and will receive circular arrow directional signs that will be mounted on posts; and

WHEREAS, once the signs are completed and installed, it will be the responsibility of the Center City Development Parking Division to maintain the signage; and

WHEREAS, this Ordinance accepts the lowest responsive bid submitted by **Walton Enterprises Ltd. dba Walton Signage** in the amount not to exceed \$370,453.00 for the Parking Trailblazing Signage System Project; and

WHEREAS, approval of this Ordinance will be a continuation of City Council policy to complete previously approved Parking Improvements and Contingency Funded Projects; **NOW THEREFORE**,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The lowest responsive bid of **Walton Enterprises, Ltd. dba Walton Signage** in the amount not to exceed \$370,453.00 for the Parking Trailblazing Signage System Project is hereby accepted. All other bids will be considered rejected upon the execution of a contract by the successful bidder and the deposit of all required bonds and insurance certificates or the expiration of ninety (90) days from the effective date hereof, whichever occurs first.

SECTION 2. A construction contract is hereby awarded to **Walton Enterprises, Ltd. dba Walton Signage**.


SECTION 3. The following financial adjustments are hereby approved:

- a) Payment in the amount not to exceed \$370,453.00 in SAP Fund 53099000, Parking Capital Projects, SAP Project Definition 19-00013, Parking Trailblazing Signage System, is authorized to be encumbered and made payable to **Walton Enterprises, Ltd. dba Walton Signage**, for construction services.
- b) The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.
- c) This Ordinance shall be effective immediately upon passage by eight or more affirmative votes; otherwise, it shall be effective on the tenth day after passage.
