**AN ORDINANCE**

**AUTHORIZING THE FOLLOWING CONTRACTS ESTABLISHING UNIT PRICES FOR GOODS AND SERVICES FOR AN ESTIMATED ANNUAL COST OF \$165,000.00: (A) PATHMARK TRAFFIC PRODUCTS OF TEXAS, INC., IMPACT RECOVERY SYSTEMS, INC., AND SAFELANE TRAFFIC SUPPLY FOR AIRPORT SAFETY TRAFFIC CONTROL PRODUCTS, (B) CONSOLIDATED TRAFFIC CONTROLS, INC. FOR AUDIBLE PEDESTRIAN SIGNALS, AND (C) EVERBRIDGE, INC. FOR SUBSCRIPTIONS FOR AVIATION EMERGENCY NOTIFICATION .**

**WHEREAS**, bids were submitted to provide the City of San Antonio with commodities and services on an annual basis for the terms of the contracts; and

**WHEREAS**, these bids are from the following companies to furnish the City with: (A) PathMark Traffic Products of Texas, Inc. (Items 1A and 1B), Impact Recovery Systems, Inc. (Items 1C, 2A and 2B), and SafeLane Traffic Supply (Item 3) for airport safety traffic control products, (B) Consolidated Traffic Controls, Inc. for audible pedestrian signals, and (C) Everbridge, Inc. for subscriptions for aviation emergency notification; and

**WHEREAS**, the bids submitted by Centerline Supply (Item 1C) and N-Line Traffic failed to meet the City's specifications and/or requirements for airport safety traffic control products; and

**WHEREAS**, the Texas Local Government Code section 271.103 provides that a local government may purchase goods or services available under Federal supply schedules of the United States General Services Administration (GSA) and such purchase satisfies any state law requiring competitive bidding; and

**WHEREAS**, this ordinance approves three low qualifying bid contracts, one low bid contract, and one contract procured through a GSA contract; and

**WHEREAS**, all expenditures will be in accordance with the applicable fiscal year's budget approved by City Council; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The bids from the following companies to furnish the City with: (A) PathMark Traffic Products of Texas, Inc. (Items 1A and 1B), Impact Recovery Systems, Inc. (Items 1C, 2A and 2B), and SafeLane Traffic Supply (Item 3) for airport safety traffic control products, (B)

Consolidated Traffic Controls, Inc. for audible pedestrian signals, and (C) Everbridge, Inc. for subscriptions for aviation emergency notification. Copies of bids are available for inspection in the offices of the Purchasing Division of the Finance Department.

**SECTION 2.** It has been found and declared that the bid submitted by Centerline Supply (Item 1C) and N-Line Traffic failed to meet the City's specifications and/or requirements.

**SECTION 3.** Funds will be encumbered upon issuance of purchase orders and payment is authorized to the vendors identified herein. All expenditures will be in accordance with the Fiscal Year 2016 budget and such other appropriations necessary to fund the contracts through their terms as evidenced by subsequent ordinances.

**SECTION 4.** This ordinance is effective immediately upon passage by eight affirmative votes; otherwise it is effective on the tenth day after passage.
