BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:


SECTION 1. A special City Council meeting is scheduled for Monday, October 7, 2019, to be held at the Emergency Operations Center beginning at 1 p.m.:


SECTION 2. The regularly scheduled City Council meetings on October 9-10, and November 21-22, 2019 are rescheduled as follows:


