The City Council convened in a Regular Meeting. City Clerk Leticia M. Vacek took the Roll Call with the following Councilmembers present:

ACTION ITEMS FOR STAFF BRIEFING

The City Clerk read the caption for Item 4:

4. An Ordinance ordering a Charter Amendment Election for Saturday, May 9, 2015. [Leticia M. Vacek, City Clerk; Robert F. Greenblum, City Attorney]

City Clerk Leticia Vacek presented a Power Point and stated that a Charter Amendment Election would be held on Saturday, May 9, 2015 from 7:00 am to 7:00 pm to add Section 3a to the City Charter, entitled, "Limitation on Powers; Streetcar or Light Rail" providing that:

"No grant of permission to alter or damage any public way of the city for the laying of streetcar or light rail tracks shall ever be valid, and no funds shall be appropriated and no bonds or notes shall be issued or sold for the purpose of streetcar or light rail systems, unless first approved by a majority of the qualified electors of the city voting at an election containing a proposition specifically identified for and limited to such purpose."

Mrs. Vacek outlined the Election Calendar noting that the last day to Register to Vote in the May Election would be April 9, 2015. She reported that Early Voting by Personal Appearance would take place from April 27, 2015 through May 5, 2015. She stated that Election Day would be Saturday, May 9, 2015 from 7:00 am to 7:00 pm. She mentioned that Early Voting and Election Day Polling Sites would be presented to the City Council at a later date. She added that funds for the May 9, 2015 Election had been allocated in the Municipal Elections Budget. She stated that staff had coordinated said item with the Office of the City Attorney.

Mayor Taylor thanked Mrs. Vacek for the presentation and called upon the citizens registered to speak.

Nazirite Ruben Flores Perez spoke in support of said item and stated that the Streetcar would help reduce pollution.

Jack M. Finger spoke in opposition to the Streetcar Project noting that it had previously been voted down by the voters in San Antonio. He expressed concern with the disruption to streets and the high cost of the project.

Jeff Judson of the Streetcar Vote Coalition thanked the City Council for placing the Charter Amendment on the Ballot.

Mayor Taylor stated that she was supportive of placing the item on the ballot and thanked everyone that worked on the language. She asked if the language was the same as the language approved at the Governance Council Committee. Mr. Robbie Greenblum confirmed that the language was exactly the same as had been approved at the Governance Council Committee.

Councilmember Krier commended Mayor Taylor for her leadership on said issue and stated that it was important to allow the citizens to vote. He added that he was pleased that all sides had worked together on the language and come to an agreement.

Councilmember Krier moved to adopt the proposed Ordinance. Councilmember Gallagher seconded the motion. The motion prevailed by the following vote:

Councilmember Gallagher expressed concern with the city's involvement in Teen Pregnancy Prevention and stated that he could not support that portion of the program.

Councilmember Bernal expressed support for the program and stated that Teen Pregnancy was a big issue in San Antonio.

Councilmember Lopez expressed concern with repeat pregnancies by teenagers and stated that the program could have a positive impact on the community.

Councilmember Nirenberg stated that he would like to vote on the Teen Pregnancy Prevention portion separately.

Councilmember Aguirre-Rodriguez spoke of the reduction in teen births over the last five years and the positive economic impact to the city. Dr. Schlenker stated that the economic impact was \$23 Million. He noted that 1,000 more women and young girls were able to contribute successfully to the Educational System.

Mayor Taylor stated that teen pregnancy was a community and economic issue and that it was a personal priority as well. She noted that she would be recusing herself on the Teen Pregnancy Prevention portion of the item since she served on the Board of Healthy Futures Texas

Councilmember Lopez moved to adopt the proposed Ordinance without funding for Teen Pregnancy Prevention. Councilmember Viagran seconded the motion. The motion prevailed by the following vote:

John Jacks presented Item Z-6 and stated that staff and the Zoning Commission recommend approval with the following conditions: 1) All auto paint and repair work shall occur indoors; 2) A Type B landscape buffer and six-foot tall solid screen fence shall be maintained along the entire west yard, and along the portion of the east yard that is shown as an outdoor storage area on the Specific Use Authorization Site Plan, subject to clear-vision regulations in the Unified Development Code; and 3) There shall be no making of noise which exceeds 70 decibels when measured from the property line. The manner of measuring noise shall be in compliance with Section 21-56 of the City Code relating to the method of noise measurement. He reported that of seven notices mailed; none were returned in favor or in opposition.

Councilmember Viagran stated that she was pleased that the applicant had worked with the Hot Wells Neighborhood Association and provided a copy of the Restrictive Covenants.

Councilmember Viagran moved to adopt the proposed ordinance with the conditions read by John Jacks. Councilmember Lopez seconded the motion. The motion prevailed by the following vote:
