

AN ORDINANCE 2018-08-16-0621

AWARDING A CONSTRUCTION CONTRACT TO E-Z BEL CONSTRUCTION, LLC IN AN AMOUNT NOT TO EXCEED \$711,414.60 FOR THE CONSTRUCTION OF THREE TRAFFIC SIGNALS, A 2018 GENERAL FUND PROJECT LOCATED IN COUNCIL DISTRICTS 4, 8, AND 10.

WHEREAS, this ordinance awards a construction contract for the construction of three new traffic signals at the intersections of (a) S. Zarzamora Street and W. Villaret Boulevard (Council District 4), (b) Prue Road and Old Prue Road (Council District 8), and (c) Judson Road and Villa Camino (Council District 10); and

WHEREAS, City advertised for construction bids in April 2018 opened bids in May 2018; and

WHEREAS, this Ordinance accepts the lowest responsive bid submitted by E-Z Bel Construction, LLC in an amount not to exceed \$711,414.60 for the construction of three new traffic signals; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The lowest responsive bid by E-Z Bel Construction, LLC for the construction of three new traffic signals in the not to exceed amount of \$711,414.60, is hereby accepted. All other bids will be considered rejected upon execution of a contract by the successful bidder and the deposit of all required bonds and insurance certificates or the expiration of ninety (90) days from the effective date hereof, whichever comes first.


SECTION 2. Payment in the amount not to exceed \$711,414.60 in SAP Fund 40099000, Other Capital Projects, SAP Project Definition 23-01771, FY 2018 Traffic Signal Installation, is authorized to be encumbered and made payable to E-Z Bel Construction, LLC, for construction services.

SECTION 3. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 4. This Ordinance shall be effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.


