

ORDINANCE 2019-12-12-1053

AUTHORIZING THE APPLICATION AND ACCEPTANCE OF APPROXIMATELY \$213,000.00 IN GRANTS TO FUND ACTIVITIES SUCH AS RECYCLING EDUCATION AND ORGANICS EDUCATION, AS WELL AS WASTE REDUCTION EFFORTS, FROM THE TEXAS COMMISSION ON ENVIRONMENTAL QUALITY FOR REGIONAL SOLID WASTE PASS-THROUGH GRANTS FOR FISCAL YEARS 2020 AND 2021 THROUGH THE ALAMO AREA COUNCIL OF GOVERNMENTS

WHEREAS, since 1996, the Texas Commission on Environmental Quality (TCEQ) has provided statewide grants to area Councils of Government for distribution to municipal and local agencies; cities, counties, and public school districts, with funds generated by fees imposed by the State on volumes of disposed municipal solid waste, and the City has received over \$4.8 million from this program, including \$142,714.00 in the 2018-2019 grant cycle; and

WHEREAS, this year's grant cycle applications will cover the 2020-2021 State of Texas Biennium and the Alamo Area Council of Governments (AACOG) Resource Recovery Committee will decide which projects are funded in FY 2020 or FY 2021; and

WHEREAS, to enable the City to expand its efforts to reduce the generation of waste through education and to encourage recycling efforts within the City, the Solid Waste Management Department (SWMD) will submit requests for grant funding for educational and outreach programs targeting waste reduction and reducing recycling contamination, and expanding the recycling video developed in 2017; and

WHEREAS, the Office of Historic Preservation (OHP) will submit requests for grant funding for the deconstruction and salvaging policy; \$30,000.00 will be requested for FY 2020 to support the development of a strategic plan for a salvaged building materials exchange program, a peer exchange and best practices for the recovery, reuse, and redistribution of building materials; and \$30,000.00 will be requested for FY 2021 to support the training of certified deconstruction contractors and contract services to provide building material warehouse support; and

WHEREAS, this ordinance authorizes the City Manager, or designee, to submit Regional Solid Waste Pass-Through Grant applications for approximately \$213,000.00 or more to the AACOG, representing the TCEQ, to support environmental programming efforts related to recycling and organics education, solid waste stream reduction and a salvaged building materials program; authorizes the acceptance of funds and execution of contracts between the City and AACOG for any of the grants awarded; and allows for supplemental grant applications, and their acceptance if awarded, should AACOG make additional funds available during their 2020-2021 grant cycle process; **NOW THEREFORE**,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager, or designee, or the Director of the Solid Waste Management Department, or designee, or the Director of the Office of Historic Preservation, or designee, is hereby authorized to apply for and accept grant funds in the amount up to \$213,000.00 from the Alamo Area Council of Governments (AACOG), for the Texas Commission on Environmental Quality (TCEQ), to support environmental programming efforts related to recycling, solid waste stream reduction and a salvaged building materials program. Should AACOG make additional funds available during their 2020-2021 grant cycle process, the City Manager or designee, or the Director of the Solid Waste Management Department or designee, or the Director of the Office of Historic Preservation, or designee, is authorized to submit supplemental grant applications and accept any additional amount of grant funds, if awarded. Copies of the grant applications are on file in the Solid Waste Management Department and the Office of Historic Preservation.


SECTION 2. The City Manager, or designee, or the Director of the Solid Waste Management Department, or designee, or the Director of the Office of Historic Preservation, or designee, is authorized to initiate, negotiate, and execute any and all necessary documents and grant contracts to effectuate the application and acceptance of the referenced grants, and to execute contract amendments pertaining to these contracts, to include: a) carry-over funds, when ascertained and approved by the funding agency through a revised notice of award; b) line item budget revisions authorized by the funding agency; c) modifications to the performance measures authorized by the funding agency and listed in the contracts so long as the terms of the amendment stay within the general parameters of the intent of the grant; d) no cost extensions; e) amendments which will provide supplemental grant funds to a grant by the funding agency in an amount up to the total amount initially awarded to the grant; f) amendments funding one time equipment purchases or defined program services; and g) changes in regulations mandated by the funding agency.

SECTION 3. Should funding be awarded, upon acceptance of this award, a new fund and internal order number will be created, upon which the award amount will be appropriated from the AACOG. A final budget for each contract, which will include SAP Internal Orders and SAP GL Accounts, will be submitted by the Solid Waste Management Department or the Office of Historic Preservation upon award.


SECTION 4. The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 5. This ordinance shall be effective immediately upon passage by eight affirmative votes; otherwise it shall be effective on the tenth day after passage hereof.
