

AN ORDINANCE 2013-11-07-0760

AUTHORIZING THE SETTLEMENT OF A LAWSUIT STYLED *LISANDRO RAMIREZ v. JOE CASTENEDA AND THE CITY OF SAN ANTONIO*, CIVIL ACTION NUMBER 5:12-CV-00810-ORG PENDING IN THE U.S. DISTRICT COURT, WESTERN DISTRICT OF TEXAS, SAN ANTONIO DIVISION FOR PAYMENT OF \$175,000.00

WHEREAS, on March 3, 2013, San Antonio Police Officers responded to a police call at the Midtown Inn and Suites; and

WHEREAS, during this call, Lisandro Ramirez was injured and, as a result, brought this lawsuit against the City alleging excessive force; and

WHEREAS, Mr. Ramirez has incurred medical expenses and lost income in the past and will likely incur medical expenses and lost income in the future; and

WHEREAS, although the City of San Antonio has contested liability in this matter, it is in its best interest to settle this matter to avoid the uncertainty and risks associated with further litigation; and

WHEREAS, the parties have reached an agreed settlement of \$175,000.00 to resolve all outstanding claims, contingent upon Council approval; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The amount of \$175,000.00 is authorized to be paid from Fund 75001000, Insurance Reserve Fund and General Ledger 5402530, General Liability Claims and Cost Center 1009020010, Risk Management-Liability, and is authorized to be made payable to the Plaintiff Lisandro Ramirez and his attorneys of record as settlement of Civil Action Number 5:12-CV-00810 ORG styled *Lisandro Ramirez v. City of San Antonio*.

SECTION 2. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.


