## AN ORDINANCE

AUTHORIZING A 59-MONTH LEASE WITH AVIATION PORT SERVICES, LLC FOR OFFICE SPACE AND GROUND SUPPORT EQUIPMENT PARKING SPACE IN TERMINAL A OF THE SAN ANTONIO INTERNATIONAL AIRPORT, GENERATING \$17,028.98 IN ANNUAL REVENUE.

WHEREAS, pursuant to Ordinance 2011-03-03-0173 adopted by City Council on March 3, 2011, Aviation Port Services, LLC leases office and common space in Terminal A and ground support equipment parking space at San Antonio International Airport for its ground handling services and passenger services for airlines and charters servicing the Airport, which lease expired July 19, 2013 and is on month-to-month holdover tenancy; and

**WHEREAS**, the City and Aviation Port Services have agreed to enter into a new lease for a term of 59 months for the same spaces; **NOW THEREFORE**,

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

**SECTION 1.** The terms and conditions of a Lease with Aviation Port Services, LLC at the San Antonio International Airport are hereby approved. The City Manager or her designee is hereby authorized to execute the Lease, a copy of which is set out in **Exhibit 1**.
