STATE OF TEXAS COUNTY OF BEXAR CITY OF SAN ANTONIO

A BUDGET WORK SESSION AND REGULAR MEETING OF THE CITY COUNCIL OF THE CITY OF SAN ANTONIO WERE HELD IN THE MUNICIPAL PLAZA BUILDING, WEDNESDAY, AUGUST 28, 2013, AND THURSDAY, AUGUST 29, 2013, RESPECTIVELY.

The San Antonio City Council convened in a Budget Work Session at 2:00 pm Wednesday, **August 28, 2013,** Municipal Plaza Building, with the following Councilmembers present: Bernal, Taylor, Viagran, Saldaña, Gonzales, Lopez, Medina, Nirenberg, Chan, Soules, and Mayor Castro. **ABSENT:** None.

1. STAFF PRESENTATION ON THE FY 2014 PROPOSED BUDGET FOCUSING ON, BUT NOT LIMITED TO, THE FOLLOWING CITY DEPARTMENTS:

A. DEVELOPMENT SERVICES

Item A was not addressed. It was noted that it would be addressed the following day at the conclusion of the City Council Meeting.

2. A BRIEFING ON THE PROPOSED ORDINANCE THAT WOULD CONSOLIDATE AND EXPAND THE CITY'S NON-DISCRIMINATION PROVISIONS AND POLICIES.

Michael Bernard presented information regarding the proposed Non-Discrimination Ordinance (NDO). He explained that Councilmember Bernal had circulated a Discrimination-Free Workplace Initiative in a Council Consideration Request (CCR) in May. The Governance Committee considered the request on May 21, 2013 and requested a B Session Presentation. He stated that the City's current non-discrimination provisions appear in various sections of the City Code, Ordinances, and Policies which include: City Employment, City Board and Commission Appointments, Public Accommodations, Housing, and City Contracting & Subcontracting. He noted proposed goals of the NDO which would consolidate various Non-Discrimination Policies into one accessible chapter in the City Code, Chapter 2, Article X. Additionally, it would expand protections to include Sexual Orientation, Gender Identity, and Veteran Status. He indicated that it would require most City Contracts to include contractual assurances for policy compliance by vendors and contractors.

Mr. Bernard stated that, "Nothing in the NDO would be construed as supporting or advocating any particular lifestyle or religious view. To the contrary, it is the intention of the Ordinance that all persons be treated fairly and equally and it is the express intent of the Ordinance to guarantee to all of our citizens fair and equal treatment under the law." He highlighted the Proposed NDO Policy which prohibits discrimination against persons on the basis of Race, Color, Religion, National Origin, Sex, Sexual Orientation, Gender Identity, Veteran Status, Age, or Disability in the areas covered by the Ordinance, unless exempted by State or Federal Law. He added that it allows a religious entity or educational institution owned in whole or substantial party by a religious entity to limit employment or give an employment preference to members of the same religion.

20130829 1 of 26 LMV/lys Mr. Bernard explained that no city employee or applicant for employment with the city will be denied employment or promotion because of Race, Color, Religion, Disability, Sex, Sexual Orientation, Gender Identity, Veteran Status, Age or National Origin. He added that businesses may not deny advantages, facilities or services based on protected categories in places of Public Accommodation. He noted that exempt entities include a private club operating a hotel, motel, restaurant, or theater if facilities or services are restricted to its membership. He indicated that non-profit social, fraternal, educational, civic, political or religious organizations were also exempt. He stated that non-discrimination clauses in housing provisions are modeled after US and Texas Fair Housing Acts. He noted that the city prohibits what both the Federal and State Governments prohibits and adds Sexual Orientation, Gender Identity, and Veteran Status as protected categories. He explained that Fair Housing Regulations prohibit discrimination in the sale or rental of a home, as well as brokerage or appraisal services. He outlined exempted entities within Fair Housing noting that religious organizations may limit or give preference to members of the same religion.

Mr. Bernard reported that Non-Discrimination Provisions will apply to most City Contracts. He explained that there were exceptions such as the contracts exempted by the Small Business Economic Development Advocacy (SBEDA) Ordinance and Governmental Entities. He stated that the City Council may not discriminate when making appointments to Boards and Board Appointees may not discriminate while acting in his or her official capacity. He noted that the Title V Policy informally adopted previously for use by the city would be included for completeness. He outlined what the NDO would not do and noted that it would not attempt to legalize same sex marriage or require businesses to provide same sex benefits. He added that the Ordinance would not require business to have separate bathroom facilities or monitor use and would not regulate speech, religion, or political activity. He indicated that it would not create a new civil cause of action between parties.

Mayor Castro thanked staff for the presentation. He asked if there was a version of the NDO that previously existed. Mr. Bernard replied that there was and that it was addressed throughout the City Code. Mayor Castro asked if the law relating to Public Accommodations was being changed. Mr. Bernard confirmed that it was not changing and noted that exceptions were listed in Section 2-594 of the City Code. Mayor Castro clarified that persons with a certain belief can still serve on a Board or Commission. Mr. Bernard stated that they could keep their personal beliefs as long as they do not discriminate while serving in official capacity. Mayor Castro asked how a Board Member would be removed if they committed a discrimination offense. Mr. Bernard indicated that there must be tangible evidence of discrimination and there would have to be a finding.

Mayor Castro asked of the Equal Opportunity Office. Mr. Bernard responded that this office was responsible for initiating investigations into suspected discriminatory practices within the city. Mayor Castro asked of the added words, "Or mission" within Section 2-594 titled "Exemptions." Mr. Bernard stated that they were trying to clarify that the term applies to non-profits. Mayor Castro asked of laws related to Housing Practices. Mr. Bernard replied that they were following Federal and State Laws and added three protected categories. Mayor Castro asked of the law related to restrooms. Mr. Bernard replied that based on Texas Law; the sex of a person is defined at birth by their chromosomes. Mayor Castro stated that no one should be treated like a secondhand citizen and commended Councilmember Bernal for his leadership on the issue.

Councilmember Soules thanked everyone that had provided their input on the NDO. He stated that Attorney General Greg Abbott and the three candidates that want to become the Attorney General had opposed the proposed NDO. He asked if they were wrong regarding their opinion. Mr. Bernard stated

20130829 2 of 26 LMV/lys that he believed that they were wrong and that he was not aware of any provision of these types of Ordinances that had been struck down thus far. Councilmember Soules confirmed that the proposed NDO included a carve out for religious institutions. Mr. Bernard replied that was correct. Councilmember Soules asked why so many governmental entities were exempt from the NDO. Mr. Bernard responded that the City of San Antonio did not have any authority over said entities. Councilmember Soules expressed concern with the unintended consequences of the NDO.

Councilmember Soules asked why the Human Rights Commission was not included. Mr. Bernard stated that they did not believe it was necessary at this time and did not have the budget to implement a Human Rights Commission. Councilmember Soules asked of the filing of a complaint on a business. Mr. Bernard replied that the Equal Employment Opportunity Commission would investigate same and provide findings to the City of San Antonio. He noted that anti-discrimination verbiage was already included in city contracts. Councilmember Soules asked of the discrimination claims addressed by the Affirmative Action Advisory Committee. City Manager Sculley stated that there were no discrimination claims related to sexual orientation. Councilmember Soules stated that there were many Laws, Ordinances and Directives that already offer protections to citizens and expressed concern with the language in the proposed NDO.

Councilmember Bernal stated that it was important to protect vulnerable individuals and confirmed that the protections for Veterans would be voted on separately by the City Council. He noted that he had worked with the community to incorporate their suggestions into the NDO. He outlined what the NDO would not do and stated that he believed in the spirit of the Ordinance.

Councilmember Gonzales thanked everyone that participated in the process and stated that she believes that the NDO is good for the community.

Councilmember Medina thanked everyone for their participation and stated that he understands the spirit of the NDO. He noted that he believes that the Ordinance allows the city to ensure that there is no discrimination and thanked Councilmember Bernal for his leadership on the issue.

Councilmember Chan expressed concern that the language in the NDO was vague and confusing and noted concerns with unintended consequences. She stated that there was no evidence regarding discrimination on the LGBT Community. She noted that she would like for language regarding restrooms to be more specific and that she was concerned with enforcement. She asked if there was any fiscal impact related to the NDO. Mr. Bernard replied that there was no fiscal impact. Councilmember Chan stated that she was uncomfortable with the NDO and would consider placing it on the ballot for voters to decide.

Councilmember Taylor stated that she appreciates the intent of the Ordinance but noted that she was concerned with fundamental issues. She noted that the NDO should only apply to the City of San Antonio and that businesses should adopt their own policies. She asked of the issue of private businesses being able to refuse service. Mr. Bernard replied that it was a current law that private businesses can refuse service and that would not change if the NDO was passed. He noted that businesses that have a contract with the city must agree to the Non-Discrimination Policy. Councilmember Taylor stated that there were concerns with Gender Identity and that there was a difference between opinion and discrimination.

Mr. Bernard replied that they come from various places including Federal Law and other jurisdictions. Councilmember Viagran asked of litigation filed in other Texas Cities that have passed a Non-Discrimination Policy. Mr. Bernard stated that he was not aware of any litigation. Councilmember Viagran stated that she was pleased that there would be discussion prior to filing a case for discrimination practices. She thanked everyone that had answered her questions and stated that she wanted what was best for San Antonio.

Councilmember Nirenberg stated that he agrees with the spirit of the NDO and that it was incumbent upon the City Council to protect religions freedoms and freedom of speech. He asked if protections for public accommodations were already included in the City's Non-Discrimination Policies. Mr. Bernard confirmed that they had been included for decades but did not currently include the three protected classes that were being added.

Councilmember Soules stated that he did not believe that the City Council was ready to vote on said item and would like for the citizens to vote on the issue.

Councilmember Saldaña stated that they had been working on said item for four months and asked of the protected classes being added to the City's Non-Discrimination Policy. Mr. Bernard replied that they were adding Sexual Orientation, Gender Identity, and Veteran Status to the City's Non-Discrimination Policy. Councilmember Saldaña spoke of the individuals that he believed needed protections and stated that he was supportive of the spirit of the NDO.

Councilmember Lopez expressed his support for the NDO and spoke of the need to protect Veterans and the LGBT Community. He stated that he was obligated to take care of all citizens.

Councilmember Chan stated that she did not believe that anybody should be discriminated against but was concerned with the ambiguous language of the NDO.

Mayor Castro thanked everyone that worked on the NDO and stated that he believed that the Ordinance would protect individuals while respecting religious beliefs.

ITEM 3. PUBLIC HEARINGS ON THE CITY'S 2013 PROPOSED AD VALOREM TAX RATE FOR THE FY2014 PROPOSED BUDGET AND ON THE FY 2014 PROPOSED BUDGET

Maria Villagomez stated that two Public Hearings on the City's Proposed Property Tax Rate were required by State Law. She reported that the FY 2014 Proposed Budget was presented to the City Council on August 8, 2013 and was balanced. She noted that there was no City Property Tax Rate Increase and that funding for sidewalks and drainage would be increased. She stated that the City's Consolidated Budget is 1% less than FY 2013 and that the FY 2014 General Fund Proposed Budget was less than 1% higher than FY 2013. She highlighted the \$13 million in Budget Reductions which include the elimination of 279 Civilian Positions. She mentioned that \$6.2 million was added for Service Improvements and that the FY 2014 General Fund Budget totaled \$988,890,690.

Ms. Villagomez reported that the City Current Property Tax Rate was 56.569 cents per \$100 taxable valuation and that Property Values had increased by 4.68%. She stated that the city continues its commitment to provide tax relief to Seniors and Disabled Property Owners. She spoke of the five community budget meetings that were held in August and noted that the next Public Hearing on the Tax Rate and Budget would be held on September 4, 2013.

Mayor Castro stated, "The first Combined FY 2014 Budget and 2013 Tax Rate Public Hearing is hereby opened. All persons wishing to express their views may do so. Comments must be limited to matters regarding the Budget, the Tax Rate, or both. Mention of any other matter or subject may result in termination of the speaker's presentation."

Mayor Castro called upon the individuals registered to speak.

Rick Noriega stated that he was speaking on behalf of AVANCE in support of the revitalization project in Cattleman's Square located at 908 W. Houston Street. He thanked the City Council for their continued support.

Susan Blackwood and George Block representing the San Antonio Sports Foundation spoke in support of funding for one SPARK Park in each of the 10 Council Districts. Ms. Blackwood noted the importance of shared use of spaces such as gyms to help children stay active. She thanked the City Council for their support of the San Antonio Sports Foundation. Mr. Block added his support for the 10 SPARK Parks to be included in the FY 2014 Budget. He noted that it would be a great investment for the City of San Antonio.

Weston Martinez stated that approval of the Proposed Non-Discrimination Ordinance would negatively affect the City Budget.

Commerce Street. Having heard all comments from the citizens wishing to be heard, the first Combined FY 2014 Budget and 2013 Tax Rate Public Hearing is hereby closed."

Mayor Castro asked for a briefing on said items. Rene Dominguez stated that a Small Business Taskforce had been convened in 2012 to consider how to help businesses grow and expand. He reported that that the Taskforce recommended that there be a single point of contact for Small Business Owners seeking assistance. They also recommended the promotion of a more robust entrepreneurial climate in San Antonio.

Mr. Dominguez explained that the Ordinance for Item 6 would implement facility renovations to the existing space in the ground floor of the Central Library. He explained the Design Strategy in which there would be Share Zones which would be technology-equipped for on-site and virtual teamwork. He noted that Focus Zones would provide for independent or small group work while Collaboration Zones would include open areas with work surfaces and dry erase walls.

Mr. Dominguez outlined the Interlocal Agreement for the implementation of U.S. Sourcelink within Café Commerce. He stated that the three-year Agreement would include hosting and professional

20130829 22 of 26 LMV/lys services and that payment would total \$75,000 in Year One, and \$15,000 in Years Two and Three. He added that consultant travel would not cost more than \$10,000.

Mayor Castro thanked everyone for their work on the project and commended the Small Business Task Force for their efforts. He stated that this was an exciting opportunity for Entrepreneurs, Small Business Owners and potential Small Business Owners to grow and start businesses in San Antonio. He asked when Café Commerce would be open. Mr. Dominguez replied that they planned to have the Storefront open in January 2014 and that the East Wing would be open in the Summer 2014.

Councilmember Medina asked for a briefing on said item. Rod Sanchez presented a Power Point and stated that the Graffiti Abatement Program was established in 2007. He noted that it focused on Eradication, Education/Prevention, and Enforcement and that 19 Full-Time Positions were allocated to the Program. He outlined the current Graffiti Ordinance noting that it was revised in 2010 to meet State Law requiring that the city first offer free abatement before requiring private property owners to remove graffiti. He explained that Graffiti Implement was defined as follows: Aerosol Paint Containers; Any type of felt tip marker; and Paint stick or etching tool capable of defacing glass, metal, concrete, or wood. He reported that most graffiti was applied by painting and marking but vandals also used adhesives and stickers to deface property. He stated that staff recommended that the Ordinance be amended to include Stickers or Adhesive Materials in the definition of Graffiti Implements. He added that there would be no fiscal impact to implement same. Councilmember Medina stated that this was another tool to address graffiti and that this was a best practice identified around the country.

Councilmember Lopez thanked Councilmember Medina for his leadership on said item. He asked if there was any tracking to determine if incidents were reduced after passing such Ordinances. Chief McManus replied that they had not seen a great reduction in the number of graffiti incidents but continued efforts to arrest perpetrators.

Councilmember Bernal commended Councilmember Medina for his efforts on said item.
