

**AN ORDINANCE**

**AUTHORIZING AN AGREEMENT WITH THE UNIVERSITY OF TEXAS HEALTH SCIENCE CENTER AT TYLER FOR PHYSICIAN SERVICES RELATED TO THE SAN ANTONIO METROPOLITAN HEALTH DISTRICT'S TUBERCULOSIS PREVENTION AND CONTROL PROGRAM IN AN AMOUNT UP TO \$209,451.00 FOR A PERIOD ENDING SEPTEMBER 30, 2019.**

**WHEREAS**, as the local health department for the City of San Antonio and Bexar County, the San Antonio Metropolitan Health District's (Metro Health) TB Clinic operations comprises of patient care for active and latent TB patients; and

**WHEREAS** the University of Texas Health Science Center at Tyler (UTHSCT) Heartland National TB Center is one of four Regional Training and Medical Consultation Centers (RTMCCs) in the United States, and is the only one in Texas funded by the Center for Disease Control and Prevention's Division of TB Elimination, to provide medical and technical consultation services related to various aspects of TB control; and

**WHEREAS**, as such, the UTHSCT is the only entity with this level of expertise available within the state to provide these services; and

**WHEREAS**, on September 29, 2016, City Council authorized an agreement with UTHSCT for TB physician services for high risk individuals identified as having latent tuberculosis infection (LTBI) through increased targeted TB testing for a term ending on December 30, 2017; and

**WHEREAS**, this project focuses on targeted testing and treatment for LTBI in high risk populations to prevent these infections from evolving into active TB cases; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The City Manager or her designee or the Director of the San Antonio Metropolitan Health District or her designee is hereby authorized to execute an agreement with the University of Texas Health Science Center at Tyler for physician services related to the San Antonio Metropolitan Health District's Tuberculosis Prevention and Control Program in an amount up to \$209,451.00 for a period ending September 30, 2019. A copy of the agreement, in substantially final form, is attached hereto and incorporated herein for all purposes as **Attachment I**.

**SECTION 2.** For the budget period January 1, 2018 through September 30, 2018, funding is available from General Ledger 5201040, and Internal Order Number 136000000741 and Fund 2201636034 of the TB Medical Waiver 2018-19 grant, for a total amount up to \$89,765.00.

Payment not to exceed the budgeted amount is authorized to University of Texas Health Science Center at Tyler upon issuance of a purchase order.

**SECTION 3.** For the budget period October 1, 2018 through September 30, 2019, the balance of \$119,686.00 will be appropriated in General Ledger 5201040, and a new Internal Order Number and new Fund number will be created per the Tuberculosis Waiver Project Contract. Payment not to exceed the budgeted amount is authorized to University of Texas Health Science Center at Tyler, and should be encumbered with a purchase order.

**SECTION 4.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

**SECTION 5.** This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
