

AN ORDINANCE 2015-04-09-0292

**REAPPOINTING COMMISSIONERS AND APPOINTING AN  
ALTERNATE COMMISSIONER TO SERVE ON THE MUNICIPAL  
CIVIL SERVICE COMMISSION.**

**WHEREAS**, the City Charter provides for the establishment of the Municipal Civil Service Commission, which hears disciplinary appeals of civilian employees in the classified civil service; and

**WHEREAS**, the Commission consists of three members and three alternates, who are appointed by the City Council for two-year terms; and

**WHEREAS**, the City Council also designates one of the three members to serve as chair; and

**WHEREAS**, recommendations for appointments by City staff were presented to the Governance Committee on March 25, 2015, and these appointments are now being forwarded to the full City Council for consideration; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** City Council hereby reappoints and appoints the following individuals to serve on the Municipal Civil Service Commission, in the positions designated, as follows:

Joseph S. Tartell, Commissioner  
Delia R. Trimble, Commissioner  
Richard A. Lee, Commissioner  
Leland E. Wingert, Alternate Commissioner  
Leon L. Coe, Alternate Commissioner

**SECTION 2.** All terms of office commence on June 1, 2015 and expire May 31, 2017.

All of the current members, Joseph S. Tartell, Delia R. Trimble, Richard A. Lee, and Leland E. Wingert, shall continue to serve in a hold over status through May 31, 2015, until such time as they begin their new term.

**SECTION 3.** City Council hereby designates Joseph S. Tartell as Chair of the Municipal Civil Service Commission.

**SECTION 4.** This Ordinance shall take effect immediately upon passage by eight affirmative votes; otherwise, it is effective ten days after passage.


