AN ORDINANCE

CREATING A RESIDENTIAL PERMIT PARKING ZONE ON PORTIONS OF ARSENAL STREET AND CITY STREET IN COUNCIL DISTRICT 1.

* * * * *

WHEREAS, current provisions of the City Code of San Antonio establish regulations for parking upon the public rights-of-way and parts thereof;

WHEREAS, Chapter 19 of the City Code of San Antonio provides for the creation of a Residential Permit Parking Zone;

WHEREAS, residents have petitioned the City Council for the creation of a Residential Permit Parking Zone;

WHEREAS, a parking survey has identified an influx of commuter automobiles that created unnecessary noise, pollution, traffic hazards and a deterioration of safety and other values available in the identified areas; and

WHEREAS, the creation of a Residential Permit Parking Zone reflected in this ordinance is in the public interest and for the public health, safety and welfare;

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. A Residential Permit Parking Zone is hereby created for the areas identified on Exhibit I. Permit parking hours shall be weekdays between 7am-7pm. A permit is not required at any other time.

SECTION 2. Any parking zones established under this ordinance shall remain in effect until May 1, 2015, unless reenacted or terminted by the City Council on or before that date.

SECTION 3. Should any Article, Section, Part, Paragraph, Sentence, Phrase, Clause, or Word of this Ordinance, or any appendix thereof, for any reason, be held illegal, inoperative, or invalid or if any exception to or limitation upon any general provision herein contained be held to be unconstitutional or invalid or ineffective, the remainder shall stand effective and valid as if it had been enacted and ordained without the portion held to be unconstitutional or invalid or ineffective.

SECTION 4. There is no fiscal language associated with this ordinance.

SECTION 5. There shall be a review of this ordinance by City Council no later than January, 2016. This ordinance and any associated parking zones established under this ordinance shall expire if there is not a review before that date.

SECTION 6. This Ordinance becomes effective 10 days after passage, unless it receives the eight votes requisite to immediate effectiveness under San Antonio Municipal Code § 1-15, in which case it becomes effective immediately.
