

ORDINANCE 2021-04-29-0279

AUTHORIZING ACCEPTANCE OF AN AMERICORPS VISTA GRANT AWARD FROM THE CORPORATION FOR NATIONAL AND COMMUNITY SERVICE FOR THE PERIOD OF MAY 22, 2021 THROUGH FEBRUARY 16, 2022, AND A CASH MATCH BUDGET OF \$28,272.00 TO BE FUNDED BY THE DEPARTMENT OF HUMAN SERVICES.

WHEREAS, the Corporation for National and Community Service is a federal agency that places AmeriCorps VISTA members (VISTAs) to serve full-time in anti-poverty organizations that direct projects, supervise the VISTAs, provide administrative support, and provide a financial match up to 20% of the VISTAs' living allowance; and

WHEREAS, the City has served as an AmeriCorps VISTA grantee since 2014, and this will be its sixth renewal award; and

WHEREAS, the City Manager's Office approved the submission of the application by the due date of April 9, 2021; **NOW THEREFORE**:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The acceptance of an AmeriCorps VISTA grant award from the Corporation of National and Community Service (CNCS) in an amount up to \$28,272.00 for the period May 22, 2021 through February 16, 2022, and a cash match of \$28,272.00 available in the FY 2021 Adopted General Fund Budget, are approved. A copy of the renewal grant application is on file with DHS.

SECTION 2. The negotiation and execution of any and all necessary documents to effectuate the application and acceptance of this grant; the execution grant contract amendments when approved by CNCS; and the acceptance of additional VISTAs or in-kind services, provide and the provision of the associated cash match; are approved.

SECTION 3. Upon acceptance of this award, new funds and internal order numbers will be created, upon which the award amount will be appropriated from the DHS. The proposed budget, which is attached hereto and incorporated herein for all purposes as **Attachment I**, is approved and adopted for entry in the City books.



05 Fund Centers, SAP Cost Centers, SAP Functional Areas, SA Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 5. This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.


