

AN ORDINANCE 2014 - 03 - 06 - 0132

AUTHORIZING THE EXECUTION OF AN INTERLOCAL AGREEMENT BETWEEN THE CITY OF SAN ANTONIO AND BEXAR COUNTY IN THE AMOUNT NOT TO EXCEED \$1,090,912.50 FOR DESIGN AND CONSTRUCTION MANAGEMENT SERVICES FOR BEXAR COUNTY'S JONES MALTSBERGER AT ELM CREEK PROJECT (SC-28) TO BE COMPLETED SIMULTANEOUSLY WITH CITY'S REDLAND ROAD SOUTH (LOOP 1604 TO JONES MALTSBERGER ROAD) PROJECT, A 2012 GENERAL OBLIGATION BOND FUNDED PROJECT LOCATED IN COUNCIL DISTRICT 10; AND AUTHORIZING THE ACCEPTANCE OF FUNDS IN THE AMOUNT NOT TO EXCEED \$1,090,912.50 FROM BEXAR COUNTY TO COMPLETE THE PROJECTS.

WHEREAS, the City's Redland Road South (Loop 1604 to Jones Maltsberger Road) Project is an authorized 2012 - 2017 General Obligation Bond Project that consists of reconstruction and widening of Redland Road South with continuous turn lanes in sections and to include bike lanes, curbs, sidewalks, driveway approaches, traffic-signal improvements and drainage improvements as necessary; and

WHEREAS, Bexar County's Jones Maltsberger at Elm Creek Project (SC-28) provides for elimination of low water crossings along Jones Maltsberger Road at Elm Creek including construction of sidewalks on the southeast side of Jones Maltsberger from Redland Road South to Redhorse Range; and

WHEREAS, this Ordinance authorizes the execution of an Interlocal Agreement with Bexar County in the amount not-to-exceed \$1,090,912.50 for design and construction management services for Bexar County's Jones Maltsberger at Elm Creek Project (SC-28) to be completed simultaneously with City's Redland Road South (Loop 1604 to Jones Maltsberger Road) Project and accepts funds in the amount not-to-exceed \$1,090,912.50 from Bexar County to complete the Projects; and

WHEREAS, approval of this Ordinance will be a continuation of Council's policy to collaborate and coordinate with other governmental agencies in supporting the City's commitment to maintaining and improving existing infrastructure; **NOW THEREFORE**,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or her designee is hereby authorized to execute an Interlocal Agreement between the City of San Antonio and Bexar County to incorporate Bexar County's Jones Maltsberger at Elm Creek Project (SC-28) with the construction of the City's 2012 - 2017 General Obligation Bond Redland Road South (Loop 1604 to Jones Maltsberger Road) Project and to accept funds in the amount of \$1,090,912.50 from Bexar County for the completion of Jones Maltsberger at Elm Creek Project. The Contract must be executed by all parties within 90

days of signing of this Ordinance; otherwise, the contract must be considered through a subsequent Ordinance.

SECTION 2. The following financial adjustments are hereby approved:

- a) Funds are authorized to be received from Bexar County to SAP Fund 45099000, General Obligation Capital Projects, SAP Project Definition 40-00313, Redland Rd South (1604 to Jones Maltsberger), and the budget shall be revised by increasing WBS element 40-00313-90-10-01, Bexar County Contribution and SAP General Ledger 4502280, Contribution from other Agencies, in the amount of \$1,090,912.50.
- b) The amount of \$1,090,912.50 is appropriated in SAP Fund 45099000, General Obligation Capital Projects, SAP Project Definition 40-00313, Redland Rd South (1604 to Jones Maltsberger), SAP WBS Element 40-00429-05-02-02, Construction - Bexar County and SAP General Ledger 5201140 Construction Cost.
- c) The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 3. This Ordinance shall be effective immediately upon passage by eight or more affirmative votes; otherwise, it shall be effective on the tenth day after passage.
