

#### NOTICE OF PUBLIC HEARING

Notice is hereby given that the Daingerfield Cultural Education Facilities Finance Corporation (the "Corporation"), a nonprofit corporation created by the City of Daingerfield, Texas pursuant to Chapter 337, Texas Local Government Code, will hold a public hearing on November 16, 2018, commencing at 10:00 a.m. at Clarity Child Guidance Center, in the Administrative Conference Room, 8533 Tom Slick Dr., San Antonio, Texas, 78229, to provide an opportunity for all interested persons to be heard with respect to the proposed loan from First Bank ("Bank") to the Corporation in the maximum amount of \$7,000,000 and proposed loan from the Corporation to Clarity Child Guidance Center (the "Borrower") in the same amount (collectively, the "Loans"); all pursuant to a Loan Agreement by and among the Corporation, the Bank and the Borrower.

The Loans are being made for the purpose of (a) financing and refinancing the construction, acquisition, renovation and/or equipment of new facilities to assist the maintenance of public health, including the expansion of the Living Unit to add 6 psychiatric emergency services beds and 14 acute care inpatient beds, expansion of the therapeutic recreation space including gymnasium, and the Partial Hospitalization Program area; construction of the Outpatient Services Building and parking garage; and infrastructure improvements to existing facilities, all located at 8533 Tom Slick Dr., San Antonio, Texas, 78229 (the "Project"); and (b) paying a portion of the costs of issuing the Loans. The Project is owned by the Borrower. The Loans are not payable out of taxes and are secured by and payable solely from funds provided by the Borrower.

All interested persons are invited to attend the hearing to express their views, both orally and in writing, with respect to the Loans and the Project. Any interested persons unable to attend the hearing may submit their views in writing to the President of the Board of Directors of the Corporation, c/o Orrick, Herrington & Sutcliffe LLP, Attn: Hoang Vu, 601 Main Street, 40th Floor, Houston, Texas 77002, prior to the date scheduled for the hearing.
