2. Continuation of briefing and discussion on a framework for a potential affordable housing bond

Barbara Burford presented on Owner-Occupied Rehabilitation and Reconstruction Program.

Jennifer Gonzalez asked if any money is repaid and is there a preference for any particular evaluation; disabled, elderly, first come first served.

Barbara Burford stated the money is not paid back and is first come first serve. Monte Frank pointed it out to us that first come first serve can be deemed unfair. What we are now going to do going forward is to have an application process period and market it. Also, we will have a priority pool.

Mu Son Chi asked if there is a geographical focus.

Barbara Burford stated it is a citywide program.

Rod Radle asked how this program differs from the District 5 program that offers assistance.

Adolf Torres presented on Home Ownership Incentive Program and Home Ownership Program for Employees.

Debra Guerrero stated she would like to see a delinquency ratio over a 10 year period and the foreclosure rates.

Debra Guerrero asked of revenue going back into the program over a 10 year period.

Christopher Lazaro presented on the Examples of Bond Funded Projects.

### **Loan Programs**

#### **#1 Gap Financing for New Construction**

Rod Radle asked if we are open to duplexes and four-plexes on scattered sites for rental.

Debra Guerrero asked about homeless population.

Mu Son Chi asked about the disable population, it can certainly be a category. We don't have an assessment of need. Where can we best fill the need?

Michael Taylor we don't have the data of on the amount of veterans that need affordable housing. There is a solid justification for constructing units for families for under 80% category. Then there is the 80-120%, which is the fastest increase in that demand.

Jennifer Gonzalez stated she does not disagree with the program but it's the repayment portion that is challenging.

Mu Son Chi stated he could see the smaller amounts as grant programs and would lean towards making these deferred forgivable loans to mirror federal program.

Rod Radle stated he would not be in favor for making a modification on income levels, maybe in the future, but for now I would evaluate how much funds may be available and the history of the program.
