**AN ORDINANCE**

**AUTHORIZING THE FOLLOWING CONTRACTS ESTABLISHING UNIT PRICES FOR GOODS AND SERVICES FOR AN ESTIMATED ANNUAL COST OF \$433,000.00: (A) PRINCETON MEDICAL SOLUTIONS, LLC. FOR MEDICAL VACCINES & BIOLOGICALS, (B) PETROLEUM SOLUTIONS, INC. FOR TANK LEVEL SENSING AND LEAK DETECTION PARTS & SERVICE, (C) RDO EQUIPMENT COMPANY FOR JOHN DEERE INDUSTRIAL PARTS & SERVICE, AND (D) CONSOLIDATED TRAFFIC CONTROLS, INC., ELECTROTECHNICS CORPORATION, K & K SYSTEMS, INC., PARADIGM TRAFFIC SYSTEMS, INC., TEXAS HIGHWAY PRODUCTS, AND TRAFFIC PARTS, INC. FOR SOLAR SCHOOL FLASHER AND PARTS.**

**WHEREAS**, the City is able to obtain significant savings by purchasing various materials and services on an annual contract basis; and

**WHEREAS**, these bids are from the following companies to furnish the City with: (A) Princeton Medical Solutions, LLC. for medical vaccines & biologicals, (B) Petroleum Solutions, Inc. for tank level sensing and leak detection parts & service, (C) RDO Equipment Company for John Deere industrial parts & service, and (D) Consolidated Traffic Controls, Inc., Electrotechnics Corporation, K & K Systems, Inc., Paradigm Traffic Systems, Inc., Texas Highway Products, and Traffic Parts, Inc. for solar school flasher and parts; and

**WHEREAS**, this ordinance approves three low bid contracts, and three contracts awarded to other than the low bidder(s) because the low bidder(s) did not meet the City's specifications or requirements; and

**WHEREAS**, all expenditures will be in accordance with the applicable fiscal year's budget approved by City Council; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The bids of the following companies to furnish the City with: (A) Princeton Medical Solutions, LLC. for medical vaccines & biologicals, (B) Petroleum Solutions, Inc. for tank level sensing and leak detection parts & service, (C) RDO Equipment Company for John Deere industrial parts & service, and (D) Consolidated Traffic Controls, Inc., Electrotechnics Corporation, K & K Systems, Inc., Paradigm Traffic Systems, Inc., Texas Highway Products, and Traffic Parts, Inc. for solar school flasher and parts on an annual contract basis as shown on

the attached bid tabulation sheets, are hereby accepted, subject to and contingent upon the deposit of all required bonds, performance deposits, insurance certificates and endorsements. The bid tabulation sheets are attached hereto and incorporated herein for all purposes as **Exhibit I**. Copies of the bids are available for inspection in the offices of the Purchasing Division of the Finance Department.

**SECTION 2.** It has been found and declared that the low bids of Electrotechnics Corporation (Items 7, 16, and 20), K & K Systems, Inc. (Items 16 and 20), and Traffic Parts Inc. (Item 17) for Solar School Flasher and Parts failed to meet the City's specifications and/or requirements.

**SECTION 3.** The amounts will be encumbered upon issuance of a purchase order, and payment is authorized to various vendors. All expenditures will be in accordance with the Fiscal Year 2015 and subsequent budgets that fall within the term period of this contract approved by City Council.

**SECTION 4.** This ordinance is effective immediately upon passage by eight or more affirmative votes; otherwise, it is effective on the tenth day after passage.
