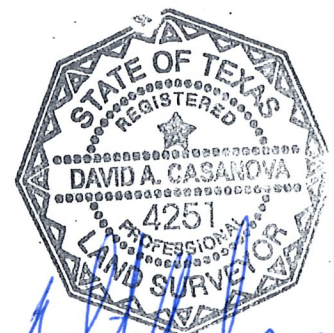

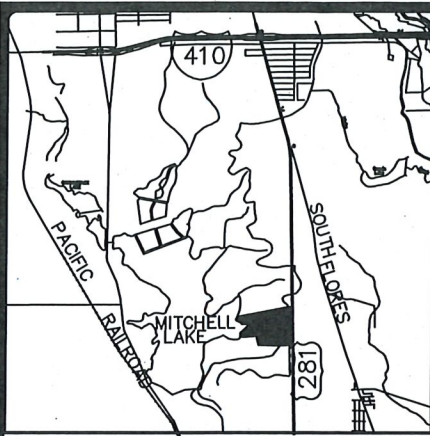

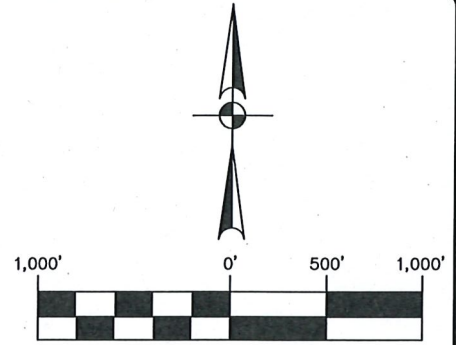


LOCATION MAP

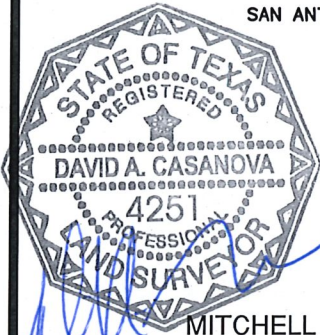
