## AN ORDINANCE 2013-12-05-0870

AN ORDINANCE APPROVING THE EXTENSION OF THE CONTRACT **ALLIED BARTON SECURITY** SERVICES FOR ADDITIONAL YEARS AND AMENDING THE HOURLY WAGE RATE FOR COMMISSIONED AND NON-COMMISSIONED SECURITY PERSONNEL **AND** ACCESS CONTROL **OFFICERS** APPROXIMATELY \$79,000.00, WITH AN ANNUAL EXPENDITURE OF APPROXIMATELY \$3,000,000.

WHEREAS, On December 16, 2010 City Council passed Ordinance 2010-12-16-1104 awarding a contract to Allied Barton for Security Guard Services, which allowed for extending the contract for up to 2 years after the initial term; and

WHEREAS, this contract allowed for the installation of commissioned security officers, non-commissioned security officers, and access control officers at City owned facilities; and

WHEREAS, this amendment will extend the contract for 2 additional years and increase the hourly rates the City will pay to Allied Barton for all positions where guards and officers provide security to compensate for increased taxes and to allow Allied Barton to continue to attract and maintain a high quality of security officers; NOW THEREFORE,

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

**SECTION 1.** An Amendment and 2 year extension with Allied Barton to provide the City with commissioned security officers, non-commissioned security officers and access control officers at City owned facilities throughout the City, is hereby approved. A copy of the Amendment is attached hereto and is incorporated by reference as **Attachment 1**.

**SECTION 2.** The amounts will be encumbered upon issuance of a purchase order, and payment is authorized to various vendors. All expenditures will be in accordance with the Fiscal Year 2014 and subsequent budgets that fall within the term period of this contract approved by City Council.

**SECTION 3.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

This AMENDMENT TO THE AGREEMENT FOR SECURITY GUARD SERVICES BETWEEN ALLIED BARTON SECURITY SERVICES AND THE CITY OF SAN ANTONIO ("Amendment") is entered into by and between the City of San Antonio, a Texas Municipal Corporation ("City") and Allied Barton Security Services ("Allied Barton" or "Contractor"), both of which may be referred to herein collectively as the "Parties."

On December 9, 2010, the San Antonio City Council passed and approved Ordinance No. 2010-12-16-1104 ("Ordinance"), authorizing "A Three-Year Contract With Allied Barton Security Services For Security Guard Services For an Estimated amount of \$2,560,000.00 Per Year," allowing the City of San Antonio Information Technology Services Department to enter into a contract with Allied Barton for security guard services. Subsequent to the passing of the Ordinance, it has become necessary to amend the Agreement to increase the hourly rate charged by Allied Barton to the City to reflect the tax and benefit cost increases for Allied Barton's employees, as allowed in Section IV. Compensation, of the Agreement.

The Parties hereby agree to amend the Agreement by revising Section IV. Compensation for the two year extension period of the Agreement to the following:

In consideration of the services performed by **CONTRACTOR**, as stated and contained herein, the City shall pay the **CONTRACTOR** fees in the following amounts:

Non-Commissioned Security Officer (Officer I) \$15.38 per hour

Commissioned Security Officer (Officer II) \$16.91 per hour

Access Control Officer (non-commissioned) \$19.99 per hour

\$20.76 per hour
