

AN ORDINANCE 2018-06-14-0457

AMENDING THE CITY OF SAN ANTONIO MAJOR THOROUGHFARE PLAN, A COMPONENT OF THE CITY OF SAN ANTONIO MASTER PLAN BY REMOVING A PROPOSED SEGMENT OF REAL ROAD, A SECONDARY ARTERIAL TYPE A REQUIRING 86 FEET OF RIGHT-OF-WAY, BETWEEN SOUTH EAST LOOP 410 AND REAL ROAD, LOCATED IN EAST BEXAR COUNTY.

WHEREAS, the City of San Antonio Major Thoroughfare Plan was adopted on September 21, 1978 by City Council as a component of the City of San Antonio Master Plan; and


WHEREAS, a public hearing was held on May 23, 2018 by the Planning Commission allowing all interested citizens to be heard: **NOW THEREFORE**;

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:


SECTION 1: The Major Thoroughfare Plan, a component of the Master Plan of the City, is amended to remove a proposed segment of Real Road, a Secondary Arterial Type A requiring 86 feet of right-of-way, between Southeast Loop 410 and existing Real Road. The Amendment is more particularly described in **ATTACHMENT "A,"** attached hereto and incorporated herein for all purposes.

SECTION 2: This ordinance shall become effective June 24, 2018.
