The City Council convened in a Regular Meeting. City Clerk Leticia M. Vacek took the Roll Call noting a quorum with the following Councilmembers present:

PRESENT: Mayor Nirenberg, Treviño, Andrews-Sullivan, Viagran, Garcia Rocha, Gonzales, Cabello Havrda, Sandoval, Pelaez, Courage, and Perry.

Mayor Nirenberg called for a moment of silence to recognize the victims who were lost due to the tragic events in El Paso, Texas and Dayton, Ohio.

1. The Invocation was delivered by Chris Johnson, Senior Pastor, First Baptist Church of San Antonio, guest of Mayor Ron Nirenberg.
2. Mayor Nirenberg led the Pledge of Allegiance to the Flag of the United States of America.

POINT OF PERSONAL PRIVILEGE

Mayor Nirenberg recognized Air Force Captain Philip Cortez and State Representative whom introduced Wing Commander Colonel Terry W. McClain of the 433rd Air Lift Wing, Joint Base San Antonio, also known as the Alamo Wing. Col. McClain inducted Mayor Nirenberg into the Honorary Commander Program and pinned Mayor Nirenberg with the Wing Guidon Lapel Pin. The Honorary Commander Program matches Military Commanders with local business and civic leaders to foster and grow understanding of the Military Mission and its impact on the surrounding community.

POINT OF PERSONAL PRIVILEGE

Mayor Nirenberg recognized Odón Cardenas, Retired Staff Sergeant whom celebrated his 100th Birthday on July 30, 2019. Mr. Odón is a decorated World War II Veteran and Former POW who served under General George Patton. Mr. Odón was a rifle expert and marksman; he was captured while fighting on the front lines in Germany. He received an American Defense Medal, Good Conduct Medal, and a European American Middle Eastern Service Medal with Three Bronze Stars. Mayor Nirenberg thanked Mr. Odón for his service and wished him a Happy Birthday. A round of applause and standing ovation ensued honoring the San Antonio American Hero.

POINT OF PERSONAL PRIVILEGE

Councilmember Perry announced Professional Engineer Day recognized on August 7th. He stated that Professional Engineers were first recognized and awarded in 1907. He stated that Engineers are required to obtain a license to ensure that public facilities, utilities, and roads were designed and built properly in compliance with laws and regulations established to ensure public safety.

POINT OF PERSONAL PRIVILEGE

Councilmember Courage recognized the Ambassador Program that occurs during the summer. He thanked Jack Morgan and Thomas Canales, District 9 residents whom interned during the summer.

Councilmember Treviño recognized Flora Baylor whom served as a summer intern with his office during the summer.

Councilmember Viagran recognized Cecilia Ramos Sunchild and Israel Espinoza whom served as summer interns with her office during the summer.

Councilmember Perry recognized Diego Hernandez whom served as a summer intern with his office during the summer.

Mayor Nirenberg recognized Ishmael Abuauara and Alvaro Flores whom served as summer interns with his office during the summer.

Councilmember Pelaez recognized Alvaro Medero, Kennedy Tatum, and Nichelle Rush whom served as summer interns with his office during the summer.

3. Approval of Minutes of the City Council Regular Meetings of June 5 - 6, 2019, the City Council Regular Meetings of June 12 - 13, 2019, and the City Council Special Meeting of June 13, 2019.

Councilmember Treviño moved to approve the Minutes of the City Council Regular Meetings of June 5-6, 2019 and June 12-13, 2019, and Special Meeting of June 13, 2019. Councilmember Courage seconded the motion. The motion to approve prevailed by the following vote:

AYES: Mayor Nirenberg, Treviño, Andrews-Sullivan, Viagran, Rocha Garcia, Gonzales, Cabello Havrda, Sandoval, Pelaez, Courage, and Perry.

INDIVIDUAL ITEMS

Items 4A and 4B were addressed jointly; City Clerk Vacek read the captions for Items 4A and 4B:

4. Presentation of the City of San Antonio 2020 Proposed Operating and Capital Budget for the Fiscal Year beginning October 1, 2019 and approving the following related Ordinances: [Erik Walsh, City Manager]

- 4A.** Ordinance setting the City's proposed maintenance and operations tax rate at 34.677 cents per \$100 of taxable valuation and the City's proposed debt service tax rate at 21.150 cents per \$100 of taxable valuation as recommended in the FY 2020 Proposed Budget. There is no increase in the city's property tax rate.

- 4B.** Ordinance setting the date, time, and place for two Budget Public Hearings and two Ad Valorem Tax Rate Public Hearings.

City Manager Walsh addressed City Council and presented the Fiscal Year 2020 Proposed Budget. He stated that the Proposed Budget maintained a minimum General Fund ending balance of 15% and maintained Public Safety spending below 66% of the General Fund.

Mr. Walsh stated that the FY 2020 Proposed Total Budget was \$2.9 billion; \$1.27 billion was allocated to the General Fund; \$937 million was allocated to Restricted Funds; and \$715 million was allocated to Capital Programs.

Mr. Walsh mentioned that FY 2019 authorized 12,404 Positions of which 4,209 were Uniform Positions and 8,195 were Civilian Positions. He stated that FY 2020 authorized 12,505 Positions of which 4,229 were Uniform and 8,276 were Civilian Positions. He stated that the Proposed Budget included 101 New Positions of which 20 were allocated as Uniform Positions and 81 were allocated as Civilian Positions.

Mr. Walsh noted that this year was challenging due to less CPS Energy Revenues in FY 2019 and FY 2020. He explained that revenue from Telecommunications/Cable Fess was lower and Interest Income was lower. Mr. Walsh also addressed revenue losses and maintained focus on needs such as reducing spending and redirecting Council Priorities such as increasing the transfer of SAWS funds and shift Parks Expenses to Parks Environmental Funds with no impact to ratepayers.

Mr. Walsh described the Equity Framework which includes training, citywide equity committee, and departmental strategies.

Mr. Walsh identified City Council Priorities as follows:

- Strong Families & Children
- Public Safety – Police
- Affordable Housing
- Streets & Sidewalks
- Property Tax Relief

Mr. Walsh reported that the Proposed FY 2020 Budget was \$1.27 billion which reflected a 1.2% increase over the \$1.26 billion FY 2019 Budget. Mr. Walsh described the following which made up the Proposed FY 2020 General Fund Budget:

- CPS Energy Payment \$353.7 million, or 28% of overall revenue
- Sales Tax \$313.1 million or 25% of revenue
- Property Tax of \$381.3 million or 30%

- Other Resources such as SAWS, cost recovery items \$227.8 million or 17%

Mr. Walsh shared the Proposed FY 2020 General Fund Revenue Growth over FY 2019:

Mr. Walsh described the Proposed General Fund Revenue Changes as follows:

- \$10 million additional revenue from SAWS
- \$2.2 million Riverbarge and Hemisphere Tower Ticket Fees
- \$300,000 Police Record Fees and Parks Facility Rentals

Mr. Walsh described Strong Families and Children Family Violence funding of \$1 million and coordinated community comprehensive family violence plan:

- \$500,000 for media campaign, education, school-based and child abuse prevention programs
- \$500,000 reserved for Delegate Agency Funding

Mr. Walsh explained the Strong Families and Children Trauma Informed Care funding of \$600,000 as follows:

- Addresses the effects of childhood psychological trauma
- Establish a certification process for organizations in the community
- Partnership with University Health Systems to provide training and technical assistance

Mr. Walsh described Public Safety Police Proposed FY 2020 Budget of \$479 million as follows:

- \$1.3 million to focus on Domestic Violence
 - 6 New Crisis Response Team Sergeants
 - 10 New SAFFE Officers to support Crisis Team
- \$272,000 proposed for Neighborhood Entertainment Zones
 - Overtime for two officers per shift
- \$2.1 million proposed for Computer Replacement and Equipment

Mr. Walsh reported the Park Police Proposed FY 2020 Budget of \$17.4 million of which \$312,000 would be allocated for four new positions to provide security for District Parks and Linear Creekways.

Mr. Walsh described the Proposed Affordable Housing Investment of \$34.4 million as follows:

- \$23.3 million for City Grants (HOME and CDGB) and General Fund
- \$5 million for LISC, San Antonio Housing Trust, and San Antonio Housing Authority (SAHA)
- \$6.2 million for potential Grants from City initiated TIRZ

Mr. Walsh outlined homelessness and the City of San Antonio \$12 million current investment:

- \$500,000 allocated to Haven for Hope for Families
- \$560,000 allocated for Strategic Plan Recommendations

Relating to Street Maintenance; Mr. Walsh outlined the proposed \$110 million as follows:

- 4,121 Centerlines maintained
- 70% Average Street Condition Index achieved in March 2020
- 1,377 Street Projects in FY 2020

Mr. Walsh denoted the Sidewalk Improvements of \$17 million which includes \$12 million from the 2017 Bond funding and \$5 million ATD as follows:

- New Sidewalks fills 35 miles of gaps
- Sidewalk repairs of 1.9 miles equals 6 usable miles and adds one new crew
- Totals 41 miles of usable Sidewalks

Mr. Walsh announced a new Micromobility Team and proposed \$219,000 as follows:

- 3 New Positions added
- Plan, identify and implement bicycle facilities program
- Oversee development of micromobility policy and visibility studies

On congestion Mitigation & Air Quality; Mr. Walsh proposed \$5.4 million as follows:

- Relieve congestion
- Reduce pollution
- Improve traffic flow
- Improve signalization
- Improve intersections

Mr. Walsh outlined the Fire Department's \$324 million Proposed Budget as follows:

- \$380,000 for 3 positions for an enhanced Squad Pilot and 1 position for training
- \$3.4 million for the Clean Cab Initiative, replacement of bunker gear, new engines at Fire Station Number 52 and Number 53, and new Hazardous Materials Truck

For Parks & Recreation; \$51.6 million Budget was proposed as follows:

- \$1.9 million for maintenance of New Parks and Greenways
- 175 acres and 13 miles of trails added in FY 2020

Mr. Walsh noted \$42.8 million for the San Antonio Public Library as follows:

- \$1.7 million for computer replacement at Branch Libraries and Facility Maintenance

Mr. Walsh proposed \$549,340 Budget for Paid Sick Leave as follows:

- 4 New Positions
- Outreach and Education
- Compliance Assistance
- Training and Resources
- Complaint-based enforcement program

For the Migrant Resource Center; an amount of \$333,000 is proposed as follows:

- Overnight shelter - Contractual
- Daytime operations – Personnel
- Funded by General Fund Contingency – Part of Community Challenge
- Reimbursed by Federal Government – General Fund Contingency replenished
- FY 2019 - 28,173 served from March 30th through August 1st
- 14% Civilian workforce volunteered

The Restricted Funds were denoted as follows:

- \$37.5 million Development Services Fund Proposed FY 2020 Budget
- \$131 million Solid Waste Enterprise Fund Proposed FY 2020 Budget
 - Solid Waste Fee \$2 Reduction for small cart
- \$2.7 million Office of Sustainability Proposed FY 2020 Budget
- \$111.6 million Airport Enterprise Fund Proposed FY 2020 Budget

Mr. Walsh added that the Stormwater Operation Fees are proposed as follows:

- \$1.30 Average annual Residential Fee Increase
- \$8.90 Average annual Non-Residential Fee Increase
- 6 New Drainage Projects
- 5th Year of Plan \$1.0 million

Mr. Walsh outlined \$24.8 million for Employee Compensation as follows:

- 3% across the board pay increase for Step Employees
- 3% of salaries for Performance Pay for Professional & Managerial Employees
- 3% salary increase for Police Officers
- 4% pay increase for Park and Airport Police
- Fire & Police longevity, step increases, and pre-fund retiree healthcare increase

Mr. Walsh mentioned Civilian Employee Healthcare as follows:

- Benefits and premiums remain the same
- New Healthcare Option Plan – Narrow Network

Mr. Walsh outlined the Proposed FY 2020 Capital Budget as follows:

- \$279 million Streets

- \$116 million Parks
- \$106 million Municipal Facilities
- \$ 84 million Drainage
- \$ 53 million IT
- \$ 52 million Air Transportation
- \$ 10.4 million Library
- \$ 7.4 million Police
- \$ 4 million Fire
- \$ 3 million Neighborhoods

Mr. Walsh reported the Capital Budget Highlights New Projects:

- \$10 million for City Council Infrastructure Projects
- \$7.5 million for Security & Cyber Projects
- \$500,000 for Ella Austin Center

Mr. Walsh reported Capital Budget Highlights from the 2017 Bond Projects as follows:

- \$6.5 million Woodlawn Lake Park Multigenerational
- \$10.4 million Brooks City Base, South New Braunfels Ave.
- \$14.7 million District 9 Senior Center

Mr. Walsh identified the following Community Outreach Events:

Lastly, Mr. Walsh identified 9 Budget Work Sessions beginning August 13th through September 11th with the Budget Adoption scheduled on Thursday, September 12, 2019. He stated that a financial tool was being used for Budget transparency, called OpenGov.

Mayor Nirenberg thanked City Manager Walsh for the Budget Presentation. He also thanked Justina Tate, Budget Director; Maria Villagómez, Deputy City Manager; Ben Gorzell, CFO; and the Budget Team for countless hours spent on Budget preparation.

Mayor Nirenberg called upon the Citizens registered to speak:

Krystal Caballero, Airport Employee and Local 2021 Union Representative stated that for years City Employees have received 1% COLA that was immediately eaten up by rising healthcare costs and inflation. She stated that a 1% COLA does not keep up with inflation when childcare, groceries, and rent continue to rise each year. She added that the Step Program be revised to correct wage compression. Ms. Caballero thanked the Mayor and City Council for standing with workers in San Antonio.

Jack M. Finger spoke in opposition of the Proposed Budget. He stated that City Council always says they have not raised the tax rate when the tax rate has gone up 5.4%. He stated that it was time for CPS Energy to raise rates again and added that the only way for any tax relief was for the State of Texas to do it.

John Bachman, Co-Executive Director of Voice for Animals spoke on the animal crisis in San Antonio. He stated that there was an overpopulation of animals which are being euthanized. He stated that San Antonio was supposed to be a no-kill community, but was not there yet. Mr. Bachman stated that overpopulation must stop and no-cost spay and neuter must increase.

Mayor Nirenberg commended City staff for presenting a balanced budget despite internal and external constraints. Mayor Nirenberg asked Mr. Walsh if there was a 6% increase in Sales Tax that was over and above the projection. Mr. Walsh replied that was over the FY 2019 Budget and had been adjusted during the forecast presented to City Council in May.

Mayor Nirenberg stated that he was pleased with program dollars allocated for Transportation. He stated that he was also pleased with the commitment keeping pace with the Affordable Housing Strategy. He stated that there would be a launch soon for a Chief Housing Officer. Mayor Nirenberg stated that City Council made it a priority to live within our constraints but also find ways for Property Tax Relief, which was accomplished while accounting for the Proposed Homestead Exemption that Councilmember Perry and Councilmember Courage championed.

Councilmember Viagran thanked City Manager Walsh for his first Budget Presentation. She thanked Councilmember Courage for bringing up the SAWS Transfer Funding during the beginning of his tenure on the Council. Councilmember Viagran stated that Animal Care Services was important to her as well as Code Enforcement, Chief Housing Officer, Homelessness, Affordable Housing, Preserving Neighborhoods, AAA Bond Rating, and Property Tax Relief.

Councilmember Pelaez stated that creating the budget was the most important task the City Council was responsible for each year. He added that the Budget presented captures everything that was discussed during the Budget Goal Setting Session. Councilmember Pelaez stated that he was worried about the SAWS piece and asked when SAWS would begin paying the increased percentage to the City. Mr. Walsh replied that the increase percentage would begin October 1, 2019. Councilmember Pelaez asked if SAWS was prepared for the change and if it would impact their budget. Mr. Walsh stated that SAWS had the capacity to make adjustments within their operating budget and that he had personally met with Mr. Puente and their Financial Staff.

Councilmember Courage thanked City Manager Walsh and City Departments that worked on the Budget. He stated that he was happy to see the Homestead Exemption part of the Budget and was a good faith effort at providing tax relief. Councilmember Courage stated that he was pleased to see the Projected SAWS increase to the City. He asked City staff to look at the long term effect on SAWS due to the increased percentage to the City. Councilmember Courage suggested a briefing from the CoSA Finance Department and SAWS CFO on the increased payment to the City.

Councilmember Gonzales congratulated City Manager Walsh for the City's AAA Bond Rating. She stated that many of her questions were similar to Councilmember Pelaez and SAWS ability to pay the City an increase amount. Councilmember Gonzales stated that if she had known that a Homestead Exemption caused SAWS to pay the City more; she might have voted differently. She asked for a SAWS briefing on the proposed increased payment to the City.

Councilmember Rocha Garcia thanked City Manager Walsh for the Budget presentation and the creative solutions to present a balanced budget. She stated that she met with SAWS CEO her first week on the job and discussed the increased percentage to the City from 2.7% to 4%. Councilmember Rocha Garcia added that SAWS staff informed her that they had been working with Ben Gorzell and City Manager Walsh on the increased percentage to the City. She stated that looked forward to a presentation from SAWS CEO and City Manager Walsh.

Councilmember Andrews-Sullivan thanked City Manager Walsh for creating a balanced budget. She stated that it was important to her to take care of City buildings and nonprofit entities. She stated that the Ella Austin Center was a pillar within District 2 and that they have had to cut their budget and their services to pay for the maintenance of the facility. Councilmember Andrews-Sullivan asked how much property the City will be selling and what effect that might have on the budget.

Councilmember Perry congratulated City Manager Walsh for defending the AAA Bond Rating. He agreed that the Budget Adoption was the most important job for City Council. Councilmember Perry stated that City Manager Walsh touted efficiencies within City departments, however; the budget was increasing \$100 million. He expressed concern with 81 new civilian positions. Councilmember Perry added that he was not concerned with the 20 additional Uniformed Positions as his constituents have asked for additional Uniformed Personnel. He mentioned that he was concerned with the SAWS increased percentage and looked forward to a discussion. Councilmember Perry asked about funding allocated for the Migrant Resource Center. City Manager Walsh stated that the funding was \$333,000 from the Operating Contingency Fund for the first quarter to ensure reimbursement from the Federal Government.

Councilmember Treviño thanked City Manager Walsh and Justina Tate, Budget Director; and staff for preparing the Proposed Budget. He stated that the City Council's most important duty was ensuring priorities were funded and action taken. Councilmember Treviño stated there were a lot of comments on the SAWS increased percentage because they have to consider the impact. He also commented on the Homestead Exemption and the effect on homeowners. He mentioned that he was drafting a memo regarding Legal Aid for renters. He added that renters could be evicted for not paying utilities and in 2016 there were over 10,000 evictions.

Councilmember Cabello Havrda thanked City Manager Walsh and his staff for working on the Proposed Budget. She stated that she was glad to see 10 new Safe Officers which was a priority for District 6. Councilmember Cabello Havrda stated that she has an interest in the specific role of the proposed Safe Officers to support the Crisis Team and looked forward to the presentation. She asked City Manager Walsh for a list of which departments would get 81 new positions in the Proposed Budget and specifically if any were allocated to Animal Care Services (ACS). City Manager Walsh stated that a new position was allocated to ACS and that he would provide a listing to City Council.

Councilmember Sandoval thanked City Manager Walsh and his team for preparing the Proposed Budget. She stated that she was happy to see Affordable Housing and the Chief Housing Officer included in the Proposed Budget. Councilmember Sandoval also thanked staff for the Sidewalk Repair Program and the Mobility Officer added to the Proposed Budget. She noted the investment of Safety, Domestic Violence, and Trauma Informed Care added to the Proposed Budget. Councilmember Sandoval reported that the Community Health and Equity Council Committee met and discussed the Board and Commissions Process and that 18 recommendations were proposed. She requested the Budget Office help with funding to improve public participation on Boards and Commissions.

Mayor Nirenberg thanked City Manager Walsh and his team for preparing the Proposed Budget. He stated that SAWS and CPS Energy were Public Owned Utility entities; therefore, serves at the pleasure of City Council and their Boards of Governance. He stated that both Utilities operate as investor owned companies which pay dividends to Stockholders. Mayor Nirenberg stated that the City of San Antonio was the Stockholder which received the dividends from both Utilities. He added that dividends go back to the public in the form of improvements for Streets, Sidewalks, Police and Fire Services which are part of the General Fund. He noted that for years; CPS Energy has contributed 14% of revenues while SAWS contributed 2.7%. He stated that both CPS Energy and SAWS operate in tandem with the City of San Antonio to serve the public and improve quality of life. Mayor Nirenberg reported that City Staff have held several discussions with SAWS regarding the increased dividends to the City that would have no impact on rates. He reported that both teams have come to a conclusion which was presented as part of the Proposed Budget.

Councilmember Courage moved to adopt the Ordinances for Item 4A and 4B. Councilmember Sandoval seconded the motion. The motion prevailed by the following vote:

AYES: Mayor Nirenberg, Treviño, Andrews-Sullivan, Viagran, Rocha Garcia, Gonzales, Cabello Havrda, Sandoval, Pelaez, Courage, and Perry.

Mayor Nirenberg called upon Jack M. Finger to speak:

Jack M. Finger spoke on Items 16 and 22, he stated that he tried to open the Contract Disclosure Forms online and the link was broken. He asked if the IT Department could fix the link. He stated that Item 10 was for Traffic Calming Construction Projects and asked what Traffic Calming was.

Councilmember Treviño stated that Items 18, 19, and 20 were Resolutions to create a Neighborhood Conservation District and initiate Historic Landmark Designation for homes on Magnolia Ave. in North Tobin Hill area. He thanked Anisa Schell, Frederica Kushner, and Mary Johnson whom were registered to speak but had to leave. He stated that he appreciated their advocacy and patience as the process moved forward.

Mayor Nirenberg exited that meeting and Mayor Pro-Tem Rocha Garcia presided.

Councilmember Treviño moved to approve the remaining Consent Agenda Items. Councilmember Pelaez seconded the motion. The motion to approve the remaining Consent Agenda Items prevailed by the following vote:

AYES: Treviño, Andrews-Sullivan, Viagran, Rocha Garcia, Gonzales, Cabello Havrda, Sandoval, Pelaez, and Courage.
