**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**


**SECTION 1.** The following appointments to the Workforce Solutions Alamo Board of Directors in the designated categories are hereby approved:

PASSED AND APPROVED this 29th day of October, 2015.




