

AN ORDINANCE 2015-10-29-0919

AUTHORIZING THE ACCEPTANCE OF UP TO \$50,000.00 IN GRANT FUNDS FROM THE TEXAS DEPARTMENT OF TRANSPORTATION FOR REIMBURSEMENT OF MAINTENANCE PROJECTS AT STINSON MUNICIPAL AIRPORT.

WHEREAS, the Aviation Department and the Texas Department of Transportation (TXDOT) have been developing a Routine Airport Maintenance Program grant for Stinson whereby the Aviation Department oversees the work and seeks reimbursement from TXDOT for up to \$50,000.00; and

WHEREAS, this funding is for maintenance projects such as roof repairs or painting of buildings; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:


SECTION 1. The City Manager, her designee, or the Director of the San Antonio Aviation Department is hereby authorized to accept the reimbursement of up to \$50,000.00 from the Texas Department of Transportation through a Routine Airport Maintenance Program (RAMP) grant.

SECTION 2. This Ordinance shall be effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.


