
**‘Connected Beyond the Classroom’
Digital Inclusion Project**

Expected Outcomes



- **The development of a flexible distance learning network that aims to:**
 - **Provide in-home school system access for up to 20,000 students within the priority neighborhoods**
 - **Not be dependent on any one technology**
 - **Leverage collective capabilities and assets of all partners (vendor contracts, buying power, fiber, vertical assets, networks, etc.,) that can be applied within each neighborhood**
 - **Use multiple funding models to grow and sustain the network**

Connected Beyond the Classroom



CBTC Collaboration Process: SAISD Pilot



The Connected Beyond the Classroom project is following a structured process to ensure collaboration and commitment to the sustainability of the network.

1. **Introduce Concept**– Complete
2. **Provide Proposal**– Complete
3. **Receive ISD Approval**– Complete
4. **Create Design Plan**–Complete
5. **Initiate Project**– Complete
6. **Updated Coverage Maps**– Complete
7. **Bring in Students**– Once students have been identified by ISD a technology pick-up process is implemented to safely provide students home equipment and installation instructions
8. **Evaluation**– TAMUSA is creating a survey and will be capturing impact through surveys and interviews with students, family, staff, leadership, and community.

Bringing in Students: SAISD Pilot



- 560 units distributed to SAISD
- Working w/SAISD to scale to current capacity of 1200 through March
- 800 additional students will be added through May once Bazan and Collins are complete in early May.
- SAISD will be lead on identifying and deploying equipment to students
- Technical support will be provided by CoSA/TAMUSA



CBTC Collaboration Process: EISD & HISD



The Connected Beyond the Classroom project is following a structured process to ensure collaboration and commitment to the sustainability of the network.

- 1. Introduce Concept**– Complete
- 2. Provide Proposal**– Complete
- 3. Receive ISD Approval**– Complete
- 4. Create Design Plan**–CoSA and selected vendor initiate a walk thru and assessment of facilities to firm up costs and timeline for the project.

- Ensure households and businesses affected by COVID-19 have the resources and tools to become financially resilient and better prepared to withstand future economic challenges.


Well-Being

Digital Inclusion Report Insights



- Respondents reflected a knowledge of the value of digital connectivity
 - Internet Access = Opportunity
- Disparities exist across the board regarding digital inclusion for San Antonio residents
- Disparities shown from the Digital Inclusion report reflect confirmed racial/income inequities
- Disparities are tied to education, income, and where you live in San Antonio

 - **Safety/Privacy**



- **Office of Minority Broadband Initiatives | \$285 Million | NTIA**

What's Next?

Comprehensive Digital Equity Strategy SA & Bexar County



Deliverables

- Alignment across key stakeholders** on the objectives (e.g., equity, focus areas, adoption levels, sustainable solutions)
- Community-level map of the gaps** for broadband, devices, digital literacy across the City and County
- Fact base on barriers to access** including availability, affordability, and adoption
- Recommendations to close the gap** impacting households, students, older adults, veterans, workforce, telemed and the justice system
- Roadmap and activation plan** with timelines, milestones, stakeholder roles, and required investment for key initiatives
- Method to track and monitor progress and outcomes**
- Buy-in from local partners and community** to ensure all committed to the strategy and execution

Step 0 (4 weeks)

Planning & Alignment

- Facilitate **stakeholder interviews** to align on shared goals and priority focus areas
- Research to understand **status of the needed data**:
 - Supply side: infra., speeds, costs
 - Demand side: household tech access, key barriers
- Engage local partners** (incl. providers) to ensure buy-in

Step 1 (6 weeks)

Understand the fact base & needs

- Conduct interviews and collect data to **map infrastructure & understand address-level options**
- Analyze barriers to access:
 - **Run surveys / focus groups** to identify key barriers to adoption
 - Partner with districts to **analyze engagement and adoption rates**
- Synthesize primary issues and **identify highest priority areas** to focus on

Step 2 (4 weeks)

Create a strategy to address the needs

- Facilitate 1-2 workshops to assess technical & financial requirements and **pressure-test solutions**
- Recommend **solutions and path forward** for key topics:
 - Strategy and initiatives
 - Ongoing data tracking
 - Partnerships and procurement
 - Funding and polices
 - Leadership, stakeholder engagement, and activation plan

Evaluate and develop solutions impacting **households, students, older adults, veterans, workforce, telemed and the justice system**
