

AN ORDINANCE 2015-06-04-0490

AUTHORIZING AN AMENDMENT TO AN INTERLOCAL AGREEMENT WITH THE SAN ANTONIO RIVER AUTHORITY IN AN AMOUNT NOT-TO-EXCEED \$17,000.00 FOR ADDITIONAL LOW IMPACT DEVELOPMENT ANALYSIS SERVICES IN SUPPORT OF THE CITY'S MISSION AREA – ENVIRONMENTAL PROTECTION AGENCY 319 GRANT.

WHEREAS, the Mission Drive-In Redevelopment Project is located on the 26-acre that was formerly the Mission Drive-In, and has already completed the redevelopment of the Old Mission Drive-In Theater into the District 3 Mission Branch Library and the Mission Marquee Plaza; and

WHEREAS, the Mission Drive-In Redevelopment site is a premier location which demonstrates and showcases the application of Low Impact Development (LID) Best Management Practices (BMPs) and features on-site storm water pollution reduction measures; and

WHEREAS, this Project will serve as testing model for LID technology uses in other locations throughout the San Antonio River Watershed and the grant funds also provide for Public Education, Unified Development Code (UDC) Review and Benefit-Cost analysis for LID technology; and

WHEREAS, an EPA 319 Grant was approved on August 4, 2011 by City Council through Ordinance 2011-08-04-0610 which accepted \$520,439.00 from the EPA and provided \$346,959.00 as a Local Match to fund the installation of on-site LID storm water pollution reduction measures in conjunction with the Mission Drive-in Redevelopment Project; and

WHEREAS, Ordinance 2013-08-15-0546 previously approved an Interlocal Agreement with the San Antonio River Authority to provide environmental and administrative services in an amount not-to-exceed \$52,843.00 in support of the EPA 319; and

WHEREAS, this Ordinance authorizes an amendment to the Interlocal Agreement between the City of San Antonio and the San Antonio River Authority for additional Low Impact Development Analysis Services in support of the City's Mission Area – Environmental Protection Agency 319 Grant in an amount not to exceed \$17,000.00; and

WHEREAS, the services included in this amendment are for completing the EPA 319 Cost-Benefit Analysis and the Final Project Report, which were not included in the original Interlocal Agreement; **NOW THEREFORE**,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or her designee is hereby authorized to execute an amendment to an Interlocal Agreement between the City of San Antonio and the San Antonio River Authority (SARA) for additional Low Impact Development Analysis Services in support


of the City's Mission Area - Environmental Protection Agency (EPA) 319 Grant, and authorizing an amount not-to-exceed \$17,000.00 payable to SARA.

SECTION 2. Fund 2600823001 entitled "EPA 319 Grant for Old Mission Drive In" and Internal Order 123000000346, are hereby designated for use in the accounting for the fiscal transaction in the authorization of this agreement. The sum of \$17,000.00 is hereby appropriated in the above designated fund. Payment is authorized to **San Antonio River Authority (SARA)**.


SECTION 3. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 4. This Ordinance shall be effective immediately upon passage by eight affirmative votes; otherwise it shall be effective on the tenth day after passage hereof.
