

AN ORDINANCE 2015-02-19-0121

**AUTHORIZING THE STREET MEMORIAL DESIGNATION “SPC DANE BALCON WAY” TO MILITARY DRIVE BETWEEN THE CROSS STREETS OF HUNT LANE AND SEQUOIA HEIGHT, IN CITY COUNCIL DISTRICT 6, SAN ANTONIO, TEXAS.**

**WHEREAS**, the Development Services Department received an application request from Dr. Carla Sizer, mother of Spc. Dane R. Balcon and sponsored by Northside Independent School District to include “SPC Dane Balcon Way” as a memorial designation to Military Drive between the cross streets of Hunt Lane and Sequoia Height as a lasting memorial to Dane Balcon, a graduate of Warren High School, to honor his military service and made the ultimate sacrifice for his country; and

**WHEREAS**, the Development Services Department staff was tasked with implementing this request through the street naming/memorial process as required by Chapter 6 of the City Code; and

**WHEREAS**, this request was forwarded to and reviewed by all City of San Antonio departments and outside agencies and no opposition was identified; and

**WHEREAS**, staff conducted a technical review finding it to conform to City Code requirements for memorial designations; and

**WHEREAS**, notice of this request to add a memorial designation to said street was properly posted at City Hall and notice was mailed to affected property owners, the notice requirements for street memorial designations has been satisfied in accordance with Chapter 6 of the City Code and further, no written opposition has been received to the name change from affected property owners; and

**WHEREAS**, a public hearing before the Planning Commission was held on January 28, 2015 allowing all interested persons to be heard; and

**WHEREAS**, the Planning Commission approved a resolution in support of “SPC Dane Balcon Way” as a memorial designation to Military Drive between the cross streets of Hunt Lane and Sequoia Height; **NOW THEREFORE**,

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** Military Drive in City Council District 6 between the cross streets of Hunt Lane and Sequoia Height is hereby given the memorial designation of “SPC Dane Balcon Way.” The location is specifically depicted in Attachment 1. City staff is directed to provide appropriate

signage to this effect specifically at the two entrances to Warren High School located off Military Drive.

**SECTION 2.** Funds generated by this ordinance will be deposited as per the table below:

**SECTION 3.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

**SECTION 4.** This ordinance is effective immediately upon receipt of eight affirmative votes; otherwise, it is effective 10 days after passage.
