

ORDINANCE 2020-12-17-0918

APPROVING THE FOLLOWING CONTRACTS ESTABLISHING UNIT PRICES FOR GOODS AND SERVICES FOR AN ESTIMATED ANNUAL COST OF \$2,052,020.00, INCLUDED IN THE RESPECTIVE DEPARTMENT'S FY 2021 ADOPTED BUDGET: (A) CSE PROFESSIONAL SERVICES LLC, DBA CJ BEDS, FOR FIRE STATION MATTRESS SETS; (B) SIRCHIE ACQUISITION COMPANY, LLC, FOR NARCOTIC TEST KITS FOR SAPD; (C) PERKINELMER HEALTH SCIENCES, INC., FOR PERKINELMER INSTRUMENT MAINTENANCE AND SERVICE SUPPORT SERVICES FOR THE JANUS 8 TIP PLATFORM; AND (D) ALLIED UNIVERSAL SECURITY SERVICES FOR A CHANGE ORDER TO THE ANNUAL CONTRACT FOR SECURITY STAFFING SERVICES.

WHEREAS, the City is able to obtain significant savings by purchasing various materials and services on an annual contract basis; and

WHEREAS, the Texas Local Government Code indicates that competitive bidding is not required under section 252.022(a)(2), which provides for a procurement necessary to protect the public health or safety; and

WHEREAS, the Texas Local Government Code indicates that competitive bidding is not required under section 252.022(a)(7)(A), which provides for any items that are available only from a sole source of supply; and

WHEREAS, this ordinance approves: (A) a low bid contract with CSE Professional Services LLC, dba CJ Beds, for fire station mattress sets; (B) a contract with Sirchie Acquisition Company, LLC, for narcotic test kits for the San Antonio Police Department procured on the basis of the public health and safety exemption; (C) a sole source contract with PerkinElmer Health Sciences, Inc., for Perkin Elmer instrument maintenance and service support for the JANUS 8 Tip platform; and (D) a change order to the Annual Contract for Security Staffing Services with Allied Universal Security Services; and

WHEREAS, all expenditures will be in accordance with the applicable fiscal year's budget approved by City Council; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The following bids to furnish the City with goods and services on an annual basis as shown on the attached bid tabulation sheets are hereby accepted, subject to and contingent upon the deposit of all required bonds, performance deposits, insurance certificates and endorsements: (A) CSE Professional Services LLC, dba CJ Beds, for fire station mattress sets; (B) Sirchie Acquisition Company, LLC, for narcotic test kits for the San Antonio Police Department; (C) PerkinElmer Health Sciences, Inc., for Perkin Elmer instrument maintenance and service support for the JANUS 8 Tip platform; and (D) a change order to the Annual Contract for Security Staffing

Services with Allied Universal Security Services. The bid tabulation sheets are attached hereto and incorporated herein for all purposes as **Exhibit I**. Copies of the bids are available for inspection in the offices of the Purchasing Division of the Finance Department.

SECTION 2. Funds will be encumbered upon issuance of purchase orders, and payment is authorized to the vendors identified herein. All expenditures will be in accordance with the Fiscal Year 2021 budget, and such other appropriations necessary to fund the contracts through their terms as evidenced by subsequent ordinances.

SECTION 3. This ordinance is effective immediately upon passage by eight affirmative votes; otherwise it is effective on the tenth day after passage.

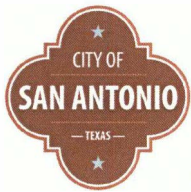

WHEREAS, pursuant to Ordinance No. 2015-12-03-1009 the City contracts with Allied Universal Security Services (“Allied Universal”) for security staffing services at various City facilities; and

WHEREAS, the contract began on December 30, 2015 and, as renewed and extended, ends on December 31, 2020 (hereinafter referred to as “the Contract”); and

WHEREAS, Parties agree to extend the Contract for an additional four-month period ending April 30, 2021, and such extension is in the City’s best interest; and

WHEREAS, this Change Order is issued pursuant to the Governor’s State of Emergency Proclamation dated March 13, 2020, as amended in subsequent Executive Orders, the Mayor’s Declaration of Public Health Emergency in response to the coronavirus (COVID-19) pandemic, and Section 418 of the Texas Government Code, and is directly related to that emergency and necessary for the preservation of public health and safety; **NOW THEREFORE:**

This contract is hereby amended as follows:

1. CHANGE ORDER

- A. Section 005 - SUPPLEMENTAL TERMS & CONDITIONS, the Original Contract Term is hereby revised to extend the Contract for an additional ~~three~~ month period and reads as follows:

Original Contract Term.

This contract began on December 30, 2015 and shall terminate on April 30, 2021.

B. Section 005 - SUPPLEMENTAL TERMS & CONDITIONS, the Renewals and Temporary Short Term Extensions sections are deleted in their entirety.

2. PROVISIONS REMAIN IN EFFECT

All other terms, conditions, covenants and provisions of the above referenced contract, as previously amended, not specifically mentioned herein and revised by this document, are retained in their entirety, unchanged, and remain in full force in effect for the duration of said contract, and any renewals thereof.

3. ENTIRE AGREEMENT

This contract, as amended, embodies the complete agreement of the parties hereto with regard to the subject matter contained herein, superseding all oral or written previous and contemporary agreements between the parties relating to matters herein.
