# AN ORDINANCE 2014 - 08 - 21 - 0609

# AUTHORIZING THE EXTENSION OF LINE-OF-DUTY LEAVE FOR FIRE ENGINEER ROBERT FULLERTON.

**WHEREAS**, section 143.073 of the Texas Local Government Code provides that a firefighter injured in the line of duty is entitled to line-of-duty injury leave with full pay for a period commensurate with the injury and not to exceed one year; and

**WHEREAS**, section 143.073 also provides that a municipality's governing body may extend the line-of-duty injury leave beyond one year; and

WHEREAS, San Antonio Fire Department Engineer Robert Fullerton was injured in the line of duty on June 8, 2010, and, as a result, required leave in excess of one year to address said injury; and

WHEREAS, Engineer Fullerton is requesting an extension of line-of-duty injury leave beyond one year for the period June 8, 2011, to July 22, 2012, and from August 20, 2012, to October 27, 2012; and

WHEREAS, approving the requested extension will restore 1002 hours of accrued leave to Engineer Fullerton; NOW THEREFORE:

## **BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1**. An extension beyond one year of San Antonio Fire Department Engineer Robert Fullerton line-of-duty injury leave for the period June 8, 2011, to July 22, 2012, and from August 20, 2012, to October 27, 2012, is hereby approved.
