AN ORDINANCE 2014 - 09 - 18 - 0709

AUTHORIZING AN AMENDMENT TO AN AGREEMENT WITH FAMILY SERVICE ASSOCIATION WHICH WILL PROVIDE THE SAN ANTONIO METROPOLITAN HEALTH DISTRICT A CUMULATIVE AMOUNT UP TO \$96,860.00 FOR THE PROVISION OF ORAL HEALTH SERVICES TO HEAD START ENROLLEES FOR A TERM THAT COMMENCED OCTOBER 1, 2013 AND TERMINATES JANUARY 31, 2015.

WHEREAS, on an annual basis, the San Antonio Metropolitan Health District's (Metro Health) Oral Health Program provides diagnostic and preventive care to more than 12,000 children living in poverty by providing services in non-traditional settings, such as Head Start and on campuses of local Title I elementary schools; and

WHEREAS, Head Start is a federally-funded program whereby Family Service Association (Family Service) provides day care, education, child development, nutrition and social services, health and disability assessment and parent involvement, both on a full and part-time basis; and

WHEREAS, these programs are designed to serve children ages 3 to 5 years whose parents' income meets Administration for Child, Youth and Families Guidelines; and

WHEREAS, approximately 23% of children enrolled in the City's Head Start Program are not covered through Texas Medicaid or the Children's Health Insurance Plan (CHIP); and

WHEREAS, during the 2010-2011 school year more than 1,850 children that are enrolled in Head Start were identified with untreated decay; and

WHEREAS, case management services are provided by Metro Health dental staff to assist participating children to receive needed treatment and to connect families to a source of ongoing care in the community; and

WHEREAS, Metro Health has provided Head Start dental services for Family Service for the past several years; and

WHEREAS, City Council most recently authorized a dental service agreement with Family Service on September 19, 2013 for Metro Health's provision of oral health services, including oral health assessments and preventative care such as fluoride varnish applications, for children enrolled in the Head Start Program; NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or her designee, or the Director of the San Antonio Metropolitan Health District (Metro Health) or his designee is authorized to execute an amendment to agreement with the Family Service Association which will provide Metro Health a cumulative amount up to \$96,860.00 for the provision of oral health services to Head Start enrollees for a term that commenced October 1, 2013 and is now extended to January 31, 2015. A copy of the amendment is attached hereto and incorporated herein for all purposes as **Attachment I.**

SECTION 2. Funds generated by this ordinance will be deposited into Fund 29836000, Internal Order 836000000022 and General Ledger 4502280.

SECTION 3. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 4. This ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.

AMENDMENT TO DENTAL SERVICES AGREEMENT

This amendment is entered into by and between the City of San Antonio, a Texas Municipal Corporation, (hereinafter referred to as "City") acting by and through the San Antonio Metropolitan Health District (hereinafter referred to as SAMHD), pursuant to Ordinance No. 2013-09-19-0654 passed and approved on September 19, 2013, and Family Service Association, (hereinafter referred to as "Family Service"), both of which may be referred to herein collectively as the "Parties".

The Parties hereto severally and collectively agree, and by the execution hereof are bound, to the mutual obligations herein contained and to the performance and accomplishment of the tasks hereinafter described.

WHEREAS, the City entered into a contract with Family Service to provide professional dental services as part of Family Service's Head Start program pursuant to an Agreement (hereinafter referred to as "the Agreement") that commenced on October 1, 2013 and terminates on January 31, 2015; and

WHEREAS, it is in the best interest of the City that an Amendment of the Agreement now be executed that expands the scope of services to be provided by the City and the level of compensation to be provided by Family Service; NOW THEREFORE:

City and the Contractor agree to amend the Agreement as follows:

- 1. Article II. is hereby amended by adding Section 2.12 as follows:
 - 2.12 The SAMHD will provide data entry for all dental evaluations and records related to services provided and case management for those children that need immediate care.
- 2. Article VI. is amended by replacing Section 6.1, and its subsections, in its entirety, as follows:
 - 6.1. Family Service agrees that it will pay up to an amount of NINETY SIX THOUSAND EIGHT HUNDRED AND SIXTY DOLLARS AND NO/100THS (\$96,860.00) to City for services provided under this agreement, as follows:
 - 6.1.1 An amount up to \$24,900.00 for the period beginning October 1, 2013 and ending on January 31, 2014; and
 - 6.1.2 An amount up to \$71,960.00 for the period beginning February 1, 2014 and ending on January 31, 2015.
