

ORDINANCE 2019-10-03-0803

AUTHORIZING A TASK ORDER TO A JOB ORDER CONTRACT WITH BELT BUILT CONTRACTING LLC IN AN AMOUNT NOT TO EXCEED \$195,077.12 FOR THE LACKLAND TERRACE PARK PROJECT, A 2017 BOND FUNDED PROJECT, LOCATED IN DISTRICT 4.

* * * * *

WHEREAS, on May 6, 2017, the City approved the 2017 Bond Program authorizing \$300,000.00 for improvements to Lackland Terrace Park located in Council District 4; and

WHEREAS, this project will provide for basketball canopy lighting and shade canopies over the basketball court and playground providing park visitors with shade during hot, sunny weather and light for use of the court after dark; and

WHEREAS, construction is anticipated to begin in October 2019 and estimated to be completed by March 2020; and

WHEREAS, this project was selected to utilize the Job Order Contracting (JOC), an alternative Project delivery method which ten contractors were approved through Ordinance 2019-02-21-0134 by City Council on February 21, 2019; and

WHEREAS, assignment of JOC contractors to specific jobs is based on the contractor's current workload, overall capacity, and familiarity with a specific facility, expertise in completing specific task and/or managing a specific trade needed to carry out the requested repair or rehabilitation; and

WHEREAS, of the ten contractors, Belt Built Contracting LLC was selected to submit an estimate and project schedule for this Project; and

WHEREAS, this contract will be awarded in compliance with the Small Business Economic Development Advocacy (SBEDA) Program, which requires contracts be reviewed by a Goal Setting Committee to establish a requirement and/or incentive unique to the particular contract in an effort to maximize the amount of small, minority, and women-owned business participation on the contract; and

WHEREAS, the Goal Setting Committee set a 24% Minority/Women Business Enterprise (M/WBE) subcontracting goal and a 4% African American Business Enterprise subcontracting goal; and

WHEREAS, Belt Built Contracting LLC has committed to a 24% M/WBE and 4% AABE subcontractor participation; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or designee, or the Director of the Transportation and Capital Improvements Department or designee, is authorized to execute a task order to a Job Order Contract with Belt Built Contracting, LLC for the Lackland Terrace Park project in the amount not to exceed of \$195,077.12.


SECTION 2. Payment is authorized to be encumbered and made payable to Belt Built Contracting, LLC for installation of canopy lighting and shade canopies at Lackland Terrace Park in an amount not to exceed \$195,077.12 in Fund 45099000, WBS Element 23-01674-05-02-01, and General Ledger 5201140.

SECTION 3. Payment is limited to the amounts budgeted in the Operating and/or Capital Budget funding sources identified. All expenditures will comply with approved operating and/or capital budgets for current and future fiscal years.

SECTION 4. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.


SECTION 5. This ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.


