### **BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** Christal A. Campbell (Category: Airline Representative), Vanessa Lacross Hurd (Category: Arts & Cultural Community), Rudy D. Garza (Category: Chamber Representative), Roberto R. Rodriguez (Category: Chamber Representative), Tammy L. Peacock-Werline (Category: Paseo Del Rio Association), Maria A. Martinez (Category: San Antonio Hotel & Lodging Association), Timothy E. Sullivan (Category: San Antonio Hotel & Lodging Association) are appointed, and Henry Brun (Category: Arts & Cultural Community), Larry S. Anthis (Category: Chamber Representative), Geoffrey W. Crabtree (General Community), Patricia L. Frank (General Community), Frank J. Miceli (Category: General Community), Khavischal A. Tiwari (Category: General Community), Michael D. Cortez (Category: Market Square Representative), Johnny Hernandez (Category: Mayoral Appointee), Justin R. Holley (Category: San Antonio Hotel & Lodging Association), William R. Petrella (Category: San
