### ROLL CALL

The City Council convened in a Regular Meeting. Acting City Clerk Tina J. Flores took the Roll Call noting a quorum with the following Councilmembers present:

1. The Invocation was delivered by Dr. Jerry William Dailey of Macedonia Missionary Baptist Church, guest of Councilmember Cabello Havrda, District 6.
2. Mayor Nirenberg led the Pledge of Allegiance to the Flag of the United States of America.
3. Approval of Minutes from the City Council Meetings of May 28, 2020 and June 3, 2020

Councilmember Courage moved to approve the Minutes of May 28, 2020 and June 3, 2020.

Councilmember Rocha Garcia seconded the motion. The motion prevailed by the following vote:

### POINT OF PERSONAL PRIVILEGE

Mayor Nirenberg recognized the Consul General of Mexico, Ruben Minutti Zanatta and welcomed him to San Antonio. He acknowledged that the Consul General had multiple connections to Texas, as he received his law degree from the University of Texas at Austin and earned his Ph.D. from the National Autonomous University of Mexico (UNAM) which is an extension campus located in Hemisfair Park in San Antonio. Mayor Nirenberg stated that the Consul General has had a distinguished career as an academic in Mexico in constitutional and administrative law, had authored several works, and advised parliamentary groups and committees of the Mexican Congress. He noted that the Consul General had served for over 15 years as the Magistrate at the Administrative Court of Mexico City.

Consul General Minutti Zanatta joined the meeting virtually and thanked the Mayor and City Council and recognized the extraordinary response from the City of San Antonio to the COVID-19 crisis. He noted that the San Antonio leadership and day-to-day decisions had been crucial for the community. He

added that he worked tirelessly to consolidate and deepen the friendship and mutual understanding between our societies with the goal to promote political dialogue and boost cooperation with Mexico and San Antonio.

Councilmember Sandoval stated that the Consul General had produced a translation of the U.S. Constitution into Spanish. She highlighted Item 7 which was the approval of a five-year lease with the Instituto Cultural de Mexico located in Hemisfair Park effective March 1, 2021 through February 28, 2026. She thanked the Consul General for his participation in the City Council meeting.

Councilmember Treviño stated that he was elated to welcome the Consul General. He noted that City Council recently supported a two-year, \$500,000 Planning Grant for the National Institute of Mexican American History of Civil Rights. Councilmember Treviño added that it would be a natural partnership to work with the Cultural Institute. He added that he was very proud that District 1 was the home of UNAM, San Antonio which added vibrancy, culture, and value to Downtown San Antonio.

Councilmember Courage welcomed the Consul General and stated that the previous Consul General was very well received in San Antonio. He stated that he looked forward to personally visiting with the Consul General at the earliest possible time.

Councilmember Gonzales noted that 97% of the residents in her district were of Mexican descent. She mentioned that she worked with the previous Consul General on educational programs and revived some cultural celebrations, such as Posadas. She welcomed the Consul General and stated she looked forward to working with him.

Councilmember Rocha Garcia congratulated the Consul General and was excited to note that the he was a fellow Longhorn. She stated that she was interested in working with him on a virtual Día de los Muertos celebration.

Councilmember Perry stated that he looked forward to meeting the Consul General personally to discuss his vision and what he would like to accomplish while assigned to this position.

Mayor Nirenberg stated that on behalf of the entire City Council they very much looked forward to his service and working with him. Consul General Minutti Zanatta thanked the Mayor and City Council for their warm welcome and noted that he was ready to work together in anything for the community.

John Peterek, Assistant to the City Manager read the caption for Item 4.

4. Ordinance confirming the appointment of Tina Flores as City Clerk for the City of San Antonio. [Ben Gorzell, Chief Financial Officer; Lori Steward, Director, Human Resources]

Mayor Nirenberg stated that in February 2020, he appointed an Ad-Hoc City Clerk Search Committee to fill the City Clerk vacancy left by Leticia M. Vacek. He mentioned that the Ad-Hoc Committee consisted of Chairwoman Andrews-Sullivan, Councilwoman Rocha Garcia, Councilwoman Sandoval, and Councilmember Courage. He noted that the committee met on March 6, 2020 to review the recruitment timeline and outreach plan. He noted that the search for the City Clerk officially began on March 18, 2020 and that a total of 32 qualified candidates had applied for the position. He stated that six candidates participated in interviews with the Ad-Hoc Committee and of those six, a final three were invited to participate in a more extensive interview with the full City Council during an Executive

Session on August 14, 2020.

Mayor Nirenberg stated that it gave him great pleasure to announce that Tina J. Flores was selected to be appointed as the City Clerk for the City of San Antonio. He stated that City Clerk Flores had been with the City for almost 19 years in various leadership roles. He noted that her tenure began in 2001 as an Office Assistant with the Convention & Sports Facilities Department and then joined the Office of the City Clerk in 2004. He mentioned that City Clerk Flores worked in the Office of the City Auditor for approximately three years, was appointed as Deputy City Clerk in January 2020, and was serving as Acting City Clerk since March 2020. He stated that City Clerk Flores had a Bachelor of Art in Business Administration, Master's Degree in Business Administration, and Master's Degree in Jurisprudence.

Mayor Nirenberg thanked City Clerk Flores for all her hard work during the pandemic and noted that she put her heart and soul into serving the City of San Antonio. He stated he looked forward to making her the official City Clerk.

Councilmember Andrews-Sullivan thanked Mayor Nirenberg for the opportunity to serve as the Chair of the Ad-Hoc Committee. She mentioned that the process began during the uncertainty of the pandemic, but it was her goal to make sure that even in the midst of the unknown, the process was fair and that they had the most qualified applicants. She noted that they looked for candidates who would work well with the City infrastructure, City Manager, and City Council. She stated that they had found such a person in City Clerk Flores who had already been doing the job with her whole heart and unwavering confidence.

Councilmember Viagran thanked her fellow colleagues who served on the Ad-Hoc Committee and thanked City Clerk Flores for her work and dedication to the City team, community, Office of the City Clerk, and the Mayor and City Council. She also thanked City Clerk Flores for her dedication, perseverance, and continued inspiration to be a role model.

Councilmember Rocha Garcia noted her excitement with this selection and stated that she had worked with City Clerk Flores for many years in her capacity as Chair of the Ethics Review Board. She noted that she witnessed first-hand her strong compassion and resiliency and commitment to the City. She stated that one of the main reasons that City Clerk Flores was the best choice was her attention to those people who are in need within the most vulnerable communities. She stated her appreciation that a strong woman was taking this position and congratulated City Clerk Flores.

Councilmember Treviño congratulated City Clerk Flores and stated that her interview was the most impressive interview he had ever seen. He noted her enthusiasm, strength, and compassion. He noted that City Clerk Flores had already been very collaborative with his office regarding the ID Recovery Program and he looked forward to working more with her and the Office of the City Clerk.

Councilmember Gonzales congratulated City Clerk Flores and noted her impressive interview. She stated that many people do not realize all that the Office of the City Clerk does such as, archives, passports, meeting minutes, etc. She noted all the many services that are done behind the scenes that make City Council life much easier.

Councilmember Pelaez noted his admiration for City Clerk Flores and stated that she had a story to tell and he was happy to be a footnote in the next chapter of her life.

Councilmember Sandoval stated that City Clerk Flores did a wonderful job in the interview process and presented herself with knowledge, confidence, and determination. She thanked City Clerk Flores for

always taking her requests seriously specifically regarding Boards and Commissions as well as public participation. She stated that she looked forward to working with City Clerk Flores.

Councilmember Courage noted his confidence in City Clerk Flores' abilities to continue the department functioning at a high level as the department is so important to City Council and the City government.

Councilmember Cabello Havrda noted that she was inspired by City Clerk Flores' story of independence, determination, and faith. She offered her congratulations and stated that she looked forward to working with City Clerk Flores and watching the department grow.

Councilmember Perry stated that he looked forward to working with City Clerk Flores and acknowledged the excellent staff that he had personally relied upon within the department.

City Manager Walsh offered his congratulations to City Clerk Flores and noted that he looked forward to continuing their partnership and making sure she is successful in all that she wants to do.

Mayor Nirenberg noted that the City Clerk position is an extraordinarily historic one for the City. He stated that there was a long history of strong female City Clerks and he was proud to continue that legacy with City Clerk Flores appointment.

City Clerk Flores thanked the Mayor and City Councilmembers for their support on her appointment. She stated that it was an honor to serve them and the City of San Antonio. She stated that she looked forward to working with City staff and the Mayor and City Council.

Councilmember Andrews-Sullivan moved to approve Item 4. Councilmember Sandoval seconded the motion. The motion prevailed by the following vote:

Antonio Diaz noted that as an indigenous person there were many burial sites not given the recognition they deserved and noted one such issue near Milam Park.

Gavin Rogers spoke in favor of funding in support of CENTRO. He noted all the good work done by CENTRO and its staff especially during the pandemic.

Edward Romero, Vice President of Public Improvement District Operations & Community Engagement, spoke in favor of funding in support of CENTRO. He thanked the Mayor and City Council for their support of the funding that would go towards many amazing programs CENTRO offers.

Councilmember Viagran highlighted item 10, the underpass Infrastructure Project for the World Heritage Trail and acknowledged AARP for the grant to fund the project as part of a larger Public Art Project. She highlighted Zoning Item Z-5 and thanked the Highland Hills Neighborhood Association

and the developer for coming to an agreement.

Councilmember Treviño acknowledged the partnership and great work from CENTRO. He noted that he looked forward to the expansion of their outreach program and their assistance with the mobile shower unit which will be owned by the City as part of a larger holistic homeless strategy.

Councilmember Rocha Garcia thanked CENTRO for all their great work and especially for their assistance to the homeless during the pandemic. She noted her appreciation of CENTRO for placing white ribbons along the River Walk in remembrance of women gaining the right to vote in 1920.

Mayor Nirenberg echoed the sentiments on his colleagues and thanked CENTRO for all their hard work and continued partnership. He highlighted Item 15, the Airline Use Agreement for the San Antonio International Airport and noted that this was the culmination of 24 months of negotiation between the City and the airlines. He recognized Denise McElroy who was unable to but had planned to speak in favor of the item as a representative of Southwest Airlines since January 2006.

Human Resources Director Lori Steward stated that the City Charter provided for the establishment of the Municipal Civil Service Commission to hear disciplinary appeals for suspensions, demotions, and terminations, and to make recommendations to the City Manager. She noted that the Commission received approximately 10 to 15 appeals per year, with some hearings lasting up to eight hours. She stated that the Commission consisted of three regular members and three alternate members appointed by the City Council.

Ms. Steward stated that the current item was for the nomination of the two current members to be reappointed, the Chair, Joseph Tartell, and Leon Coe to be reappointed as regular Commissioners. She stated that Brenda Wingert had been recommended for appointment as the third regular Commissioner and noted some of Ms. Wingert's qualifications. She also stated that Valerie Sprague had been recommended for appointment as an alternate Commissioner. She noted that there were two additional vacancies for alternate commissioners and outreach would begin soon to fill those positions.

Councilmember Sandoval noted that there was a backlog of HR cases to be heard by the Commission due to the pandemic and inquired how many cases were backlogged. Ms. Steward stated that there were 11 cases pending a hearing and noted that these appointments were crucial to begin scheduling those cases to be heard as soon as possible. Councilmember Sandoval inquired of the time commitment required of someone serving on the Commission. Ms. Steward responded that normally suspension cases take a half-day and termination cases take a full-day.

Councilmember Sandoval inquired of the recruitment process. Ms. Steward stated that they utilize the outreach conducted through the Office of the City Clerk such as advertisements and press releases. She noted that HR reaches out to other large employers such as SAWS and CPS. She mentioned that HR was in the process of creating an outreach brochure for the Commission to fill the remaining vacancies. Councilmember Sandoval requested that a discussion be taken up in the Governance Council Committee regarding the outreach process and length of time members may serve.

Councilmember Perry noted the difficulty in filling vacancies on all Boards and Commissions due to potential candidates working full-time jobs, those who have children, etc. He noted his support for a discussion at the Governance Council Committee and suggested that an examination, reduction, or combination of Boards and Commissions would be prudent.

Councilmember Rocha Garcia echoed the support of her colleagues for a more in-depth discussion at the Governance Council Committee and noted that she is interested in more targeted outreach and how attendance could be improved to avoid loss of quorum issues.

City Manager Walsh stated that the Commission was very important as a means for employees to have the ability to appeal any disciplinary actions that it was crucial to have HR professionals that understood large organizations and HR principles with the understanding of both the employer and the employee.

**CITY MANAGER'S REPORT**

**26. City Manager's Report**

City Manager Walsh stated that the Mayor and City Councilmembers received the 2019 Annual Report for the San Antonio Fire Department (SAFD). He noted that SAFD had earned accreditation from the Commission of Fire Accreditation. He stated that accredited Fire Departments are described as community-focused, data driven, and organized. He recognized that SAFD encompassed all those things and was one of four cities in the USA and Canada that was accredited and held an Insurance Service Rating of one. He noted that the other three were Houston, Charlotte, and Vancouver, Canada.

City Manager Walsh stated that the Hero Like Her Program was award-winning and received notoriety this year and they planned to continue that program. He noted that the Whole Blood Initiative facilitated by the EMS Division of SAFD was the recipient of several awards this year. He also noted that Fire Chief Hood was recognized as the Metro Fire Chief of the Year. He stated that SAFD had been critical to the community response to the pandemic and had been responsible for a majority of the testing done at Senior/Retired Living Facilities. He commended them for their hard work and dedication.

City Manager Walsh stated that City Attorney Segovia had shared an email with the Mayor and City Councilmembers regarding the recent CDC order concerning evictions. City Attorney Segovia provided background and stated that the CARES Act expired on July 24, 2020 which provided a 120-day moratorium on eviction filings and applied to properties and/or tenants receiving federal housing assistance. He noted that President Trump issued an Executive Order on August 8, 2020 directing the CDC to consider temporarily halting residential evictions to prevent further spread of COVID-19.

City Attorney Segovia stated that the CDC issued the order to be effective on September 4, 2020 through December 31, 2020. He noted that the order was applicable in Texas and subject to state law. He stated that the order applied to all landlords, owners of residential property, and other persons with a legal right to evict. He stated that the order applied to any property leased for residential purposes including any house, building, mobile-home or land in a mobile-home park, or any similar dwelling. He noted that the order did not apply to any hotel, motel, or any other guest house rented on a temporary or seasonal basis.

City Attorney Segovia stated that tenants using the moratorium must submit a declaration to their landlord stating that they are covered by the order. He noted that there was income requirements that the individual must meet to be eligible: (1) the individual earned or is expected to earn \$99,000 or less in annual income; (2) the individual filed joint tax returns and is expected to earn \$198,000 or less in annual income; (3) the individual is not required to report income under the Income Tax Laws; or (4) the individual has received a stimulus check from the CARES Act. He noted an additional requirement that the individual must have the inability to pay their full rent or house payment because of a substantial loss of income, loss of hours, loss of job, or extraordinary medical expenses. He stated that the individual must also declare that they have used their best efforts to make timely payments. He noted that the individual must also declare that if they are evicted they will either be homeless or placed in a congregant setting with many people that would increase the risk of spreading COVID-19. He stated that the CDC had issued a form for tenants to fill-out and take advantage of this moratorium.

City Attorney Segovia stated that this did not relieve the tenant of the obligation to pay rent or comply with any other lease obligations. He noted that some evictions were permitted in cases where a tenant had conducted criminal activity or destruction of property. He stated that the Department of Justice may bring criminal charges and coordinate with local authorities to enforce the CDC order. He noted that plans regarding how local authorities could assist in enforcing the moratorium would be forthcoming.

Councilmember Rocha Garcia offered her congratulations to Chief Hood and SAFD for their video and marketing. She thanked the 30-plus firefighters that assisted her in delivering food in conjunction with the San Antonio Food Bank to a neighborhood in need. She noted that another event was scheduled for September 11, 2020 where more firefighters volunteered to deliver more food to those in need. She stated that the SAFD support of their community did not go unnoticed and recognized women firefighters and the Hero Like Her Program that was scheduled to hold an event in conjunction with Girls Empowerment Summit that was cancelled due to the pandemic.

Councilmember Courage asked if the CDC's order would stop any evictions currently in process or those that have received judgments against them for eviction but have not yet been moved out of their homes. City Attorney Segovia stated that the CDC order was not retroactive, that it would apply to those who have not had a hearing or judgement against them yet.

Councilmember Treviño inquired if the CDC declaration form was available in Spanish. City Attorney Segovia stated that the form was currently only in English but that they could work on a Spanish translation and that if the content was the same, it should have the same legal application. Councilmember Treviño suggested that the Right to Counsel Program be consulted and that the information be provided to them to assist in the work they are conducting with evictions. Lori Houston stated that another mail outreach effort was underway that would include information regarding the new CDC order and targeted areas that have high eviction ratings. Councilmember Treviño asked that his office be kept in the loop on this subject and offered his thanks to SAFD for all their hard work.

Fire Chief Hood thanked the Mayor and City Councilmembers for their appreciation of the video presented and he thanked the SAFD videographer Albert Pedroza who had been all over the world on battlefields shooting a lot of video footage. He thanked his staff and the many firefighters that continue to volunteer within the community. He noted that today would be the first graduation class during the pandemic and that these fine young individuals would begin serving their community tomorrow.

Mayor Nirenberg echoed the sentiments of his colleagues regarding the SAFD video and noted that the video highlighted the extraordinary work of the department and he thanked all firefighters for all that they do on a daily basis.

## **ADJOURNMENT**

There being no further discussion, Mayor Nirenberg adjourned the meeting at 12:14 pm.
