REQUEST:

The applicant is requesting a Certificate of Appropriateness to install wayfinding signage at multiple locations in the right-of-way. The proposed project includes installing signs with vehicle directional, vehicle logo, and hike-and bike trail information. The sign locations, all at street edges in existing right-of-ways, are scattered along a 7.5 mile north-south corridor, with the northernmost sign on S. St. Mary's Street just north of E. Cesar Chavez Blvd. and the southernmost sign on Camino Coahuilteca immediately south of Mission San Francisco de la Espada.

APPLICABLE CITATIONS:

Sec. 35-645. - Signs and Billboards on Public Property or Right-of-Way.

- (a) **General Provisions.** All non-regulatory signage on public property, on the public right-of-way, or overhanging the public right-of-way shall conform to all city codes and must be approved by the historic preservation officer prior to installation. Permits must be obtained following approval of the application. The historic preservation officer may submit an application under this section to the historic and design review commission for their recommendation prior to approving, denying, or approving with conditions the application. Memorials, markers, naming rights of public property, and recognition of charitable donations given to the City of San Antonio shall be additionally governed by existing policies for memorials and markers and/or any formal action passed by city council. Temporary displays approved by the department exercising control of the public property are authorized if in accordance with chapter 28 of the City Code of San Antonio, Texas.
- (b) **Sign Definitions.** For signage definitions, refer to subsection 35-612(b) and chapter 28 of the City Code.
- (c) **Proportion of Signs.** Signage width and height must be in proportion to the facade, respecting the size, scale and mass of the facade, building height, and rhythms and sizes of window and door openings. The building facade shall be considered as part of an overall sign program but the sign shall be subordinate to the overall building composition. Additionally, signs should respect and respond to the character and/or period of the area in which they are being placed.
- (d) **Standards for Sign Design and Placement.** In considering whether to recommend approval or disapproval of an application for a certificate to construct or alter signage on a building, object, site, or structure, the historic and design review commission shall be guided by the following standards in addition to any specific design guidelines adopted by city council:
 - (1) Primary sign design considerations shall be identification and legibility. Size, scale, height, color and location of signs shall be harmonious with, and properly related to, the overall design of the building or structure and the surrounding area.
 - (2) The number of signs on each building shall be kept to a minimum to prevent unsightly clutter and confusion.

- (3) Signs which describe, point, or direct the reader to a specific place or along a specific course, such as "entrance," "exit," and "handicap access" shall be reviewed.
- (4) All graphic elements shall reinforce the architectural integrity of any building. Signs should not disfigure, damage, mar, alter, or conceal architectural features or details and should be limited to sizes which are in scale with the architecture and the streetscape. The historic and design review commission shall be guided by the building's proportion and scale when such elements are incorporated.
- (5) Additionally, when reviewing applications for signage the historic preservation officer and the historic and design review commission shall consider the visual impact on nearby historic resources and established neighborhood character.
- (e) **Special Purpose Signs.** All special purpose signs may be approved by the historic preservation officer and shall be removed within thirty (30) days from the date of approval unless otherwise specified. If within the specified period the applicant feels there is a continued need for the special purpose sign, promotional sign or temporary sign, the applicant may file a new application to request additional display time. Non-governmental banners, pennants and flags, excluding flags included as elements of an overall streetscape or design plan, are considered special purpose signs under the provisions of this chapter and are appropriate for advertising the event and for decoration only during special events or celebrations. No permanent advertising may be regulated in this way. Temporary displays approved by the department exercising control of the public property are authorized if in accordance with chapter 28 of the City Code of San Antonio, Texas.
- (f) **Prohibited Signs.** Signs that shall not be permitted include:
 - (1) Any sign placed upon a building, object, site, or structure in any manner so as to disfigure, damage, interrupt, or conceal any window opening, door, or significant architectural feature or detail of any building;
 - (2) Roof mounted signs, except in the cases of (i) integral design with the building; (ii) a contributing sign; (iii) or otherwise allowed in this article;
 - (3) Digital and/or LED lighted signs, not to include LED light sources that do not meet the definition of a sign, with or without rotating, flashing lettering, icons or images. Except as provided below:
 - A. A public transportation agency may incorporate transit information signage into transit shelters, utilizing LED or digital technology, provided the signage is contained within or under the transit shelter, and is limited to five (5) square feet of signage area, and one (1) sign per thirty (30) linear feet of pedestrian shelter.
 - B. A public transportation agency may incorporate transit information signage into a monument sign at transit stops, utilizing LED or digital technology, provided it is limited to five (5) square feet of signage area.
 - C. A public transportation agency may incorporate transit information signage into a monument sign at transit facilities (other than transit stops), utilizing LED or digital technology, provided it is limited to seven (7) square feet of signage area.
 - D. The historic preservation officer may impose additional restrictions on illumination to ensure that the character of signs are harmonious with the character of the structures on which they are to be placed and any designated landmarks or districts in the area, provided that such restrictions are reasonably related to other conforming signs and conforming structures in the area, do not unreasonably restrict the amount of signage allowed by this section, and are in keeping with the intent of this section. Among other things, consideration shall be given to the location and illumination of the sign in relation to the surrounding buildings, the use of appropriate materials, the size and style of lettering and graphics, and the type of lighting proposed. Notwithstanding the above, applicants may not exceed illumination restrictions contained in chapter 28.
 - E. Temporary displays for permitted events are authorized if in accordance with chapter 28 of the City Code of San Antonio, Texas.
- (g) **Violations.** In those instances where a sign is erected or maintained in violation of the aforementioned restrictions, the historic preservation officer, the development services department or park police shall notify the sign's owner, agent, operator or lessee. If the owner, agent, operator or lessee fails to remove the sign within three (3) days after notification, the department of development services or the historic preservation officer may file an action in municipal court as outlined in section 28-15 City Code of San Antonio, Texas. In addition, nothing herein shall prevent the city attorney from seeking civil remedies.
- (1) **Dilapidated Signs.** All signs shall be maintained in good working condition so as to present a neat and orderly appearance. Signs and components thereof shall be maintained in good repair, free of rust, peeling, flaking, fading, broken or cracked panels, and broken or missing letters. All signs, components, supports and their surroundings shall be kept free of all sign materials, weeds, debris, trash, and other refuse. The historic preservation officer, the code compliance department, the development services department or the park police may give written notice to remove

or repair, within thirty (30) days, any sign which shows gross neglect or which is dilapidated. Failure to comply shall be considered a violation of this chapter, and the sign shall be removed at the owner's expense. Additionally, whether the sign has been designated a contributing structure shall be taken into account when evaluating the condition of the sign.

- (2) **Abandoned Signs.** A sign, including its supporting structure or brackets, shall be removed by the owner or lessee of the premises upon which the sign is located when the business which it advertises is no longer on the premises and such sign has been determined to be abandoned under the provisions of chapter 28. Such sign, if not removed within thirty (30) days from the determination of abandonment by such business, shall be considered to be in violation of this chapter, and shall be removed at the owner's expense. This does not include signs that are approved as contributing structures.


FINDINGS:

- a. The applicant has proposed to install wayfinding signage at multiple locations in the right-of-way for the Mission Trail. The signage will be located between E Cesar Chavez and Mission Espada and within the King William, Lavaca, and Mission Historic Districts.
- b. **SIGNAGE** – The proposed project includes installing signs with vehicle directional, vehicle logo, and hike-and bike trail information. The sign locations, all at street edges in existing right-of-ways, are scattered along a 7.5 mile north-south corridor, with the northernmost sign on S. St. Mary's Street just north of E. Cesar Chavez Blvd. and the southernmost sign on Camino Coahuilteca immediately south of Mission San Francisco de la Espada. Staff finds that the signage complies with UDC Section 35-645.
- c. **DESIGN REVIEW COMMITTEE** – The applicant met with the Design Review Committee (DRC) on March 24, 2020. The DRC's suggestions including ensuring the signage in public sidewalks did not obscure walking pathways and removing signs from intersections for better visibility where applicable.
- d. **ARCHAEOLOGY** – An archaeological investigation is required. Please coordinate with the City Archaeologists on the archaeological scope of work. The project shall comply with all federal, state, and local laws, rules, and regulations regarding archaeology, as applicable.

RECOMMENDATION:

Staff recommends approval based on findings a through c with the following stipulations:

- i. That the applicant coordinates with the Public Works Department and all applicable reviewing agencies to ensure that signage is not placed in a location that obstructs pedestrian traffic or obscures vantagepoints during vehicular travel.
- ii. **ARCHAEOLOGY** – The project shall comply with all federal, state, and local laws, rules, and regulations regarding archaeology.



The information included in this submittal for the above-referenced project has been reviewed by an architectural historian with the City of San Antonio Public Works Department Environmental Management Division (PWD EMD). This is in accordance with the City's Historic Preservation and Design Section of the Unified Development Code and the requirements mandated by the Antiquities Code of Texas. This review focuses on the possible effects of the proposed project on above ground historic resources only. It is understood that the referenced project is financed solely with city funding. It is further understood that the project will not incorporate TxDOT or railroad ROW and will not require coordination with TxDOT. *However, if a federal agency becomes involved (for example, with funding, licensing, permitting, and/or oversight) in the development or regulation of this project, any historic resources located within the project area and the area of potential effect will be protected under the National Historic Preservation Act.*

The proposed project includes installing signs with vehicle directional, vehicle logo, and hike-and-bike trail information. The sign locations, all at street edges in existing right-of-ways, are scattered along a 7.5 mile north-south corridor, with the northernmost sign on S. St. Mary's Street just north of E. Cesar Chavez Blvd. and the southernmost sign on Camino Coahuilteca immediately south of Mission San Francisco de la Espada.

Architectural Resources: TCI EMD hired a consultant to conduct a Historical Resources Evaluation (see attached) to identify previously recorded historical resources (buildings, structures, and objects) in and adjacent to each of 50 locations proposed for the new or relocated signs. These locations were subject to Section 106 review. A file search for each area of potential effects, defined as the land parcel for each proposed sign location and the viewshed from each parcel, was conducted to guide identification of designated historic properties. Information was gathered from the Texas Historical Commission's Texas Historic Sites Atlas documentation on National

Historic Landmarks, National Register of Historic Places properties, State Antiquities Landmarks, Official Texas Historical Markers of all types, and cemetery, military, neighborhood, and museum surveys; and the City of San Antonio’s local landmarks, districts, river and creek improvement overlay districts, and mission overlay districts. Each proposed sign location was also reviewed using Google Earth street views to corroborate the position relative to historic properties in the vicinity. The proposed sign locations are located within several historic districts including four historic districts listed in the National Register of Historic Places (Mission Parkway, Lavaca, South Alamo Street-South St. Mary’s Street, and St. John’s Seminary), two resources designated as National Historic Landmarks (Espada Aqueduct and Mission Concepción), and one National Historical Park (San Antonio Missions). The proposed sign locations are also located within several local historical designations include several landmarks, historic districts, and protective river improvement and mission overlay districts.

The following chart of an additional 18 locations was conducted by a PWD EMD architectural historian. A review of the Texas Historic Sites Atlas, historic aerial photography, COSA GIS maps, and other historical research sources was completed to determine if any known designated historic districts, designated historic resources (standing structures), or historic age resources are located within the project area.

TCI recommends that the proposed work deliver as minimal an impact as possible on any designated historic or historic-age area/neighborhood. Therefore, if sidewalks and/or curbs are reconstructed, they should be replaced in kind in order to retain historic character through orientation, scale, and materials. In the opinion of the TCI EMD, if this recommendation is followed the proposed work is anticipated to have no adverse effects to non-archeological historic resources. If the project limits expand, further research may be warranted.

If there are any land easements owned or controlled by the State of Texas or any of its political subdivisions within the project area, or if there is any federal agency involvement or jurisdiction relating to the project or its development, the Texas Historical Commission may require other archeological and cultural resource compliance efforts in addition to those required by the City's Office of Historic Preservation. In particular for historic resources (standing structures), if NHPA compliance is required on this project a review of these resources and the potential direct and secondary effects of the project on the resources will be required.

**HISTORICAL RESOURCES EVALUATION, 2017 BOND PROGRAM, WORLD
HERITAGE WAYFINDING–MISSION TRAILS PACKAGE V PROJECT,
SAN ANTONIO, TEXAS**

Prewitt and Associates, Inc., performed a file search and map review to identify previously recorded historical resources (buildings, structures, and objects) in and adjacent to each of 50 locations proposed for new or relocated signs to be installed for this 2017 Bond Program project. The objective was to document historical resources that the project could impact and, where impacts are identified, make recommendations for adjusting sign locations to avoid or minimize impacts. The project will involve installing 50 signs with vehicle directional, vehicle logo, and hike-and-bike trail information. The sign locations, all at the edges of existing streets in existing rights of way, are scattered along about 7.5 miles of north-south corridor, with the northernmost sign on South St. Mary’s Street just north of East Cesar Chavez Boulevard and the southernmost sign on Camino Coahuilteca immediately south of Mission San Francisco de la Espada. Final sign designs have not been selected yet, but they likely will consist of metal panels on stone bases standing as much as 11.7 ft tall and impacting areas 7 ft in diameter and up to 3 ft deep below the ground surface (see attached signage option images).

A file search for each area of potential effects, defined as the land parcel for each proposed sign location and the viewshed from each parcel, was conducted to guide identification of designated historic properties. Information was gathered from the Texas Historical Commission’s Texas Historic Sites Atlas documentation on National Historic Landmarks, National Register of Historic Places properties, State Antiquities Landmarks, Official Texas Historical Markers of all types, and cemetery, military, neighborhood, and museum surveys; and the City of San Antonio’s local landmarks, districts, river and creek improvement overlay districts, and mission overlay districts. Each proposed sign location was also reviewed using Google Earth street views to corroborate the position relative to historic properties in the vicinity. Based on these sources, the historian evaluated the potential for the proposed signs to have adverse, no adverse, or no effects on historic properties.

The proposed sign locations intersect a number of historic properties (see table). Federal historical designations include four historic districts listed in the National Register of Historic Places (Mission Parkway, Lavaca, South Alamo Street-South St. Mary’s Street, and St. John’s Seminary), two resources designated as National Historic Landmarks (Espada Aqueduct and Mission Concepción), and one National Historical Park (San Antonio Missions). Local historical designations include several landmarks, historic districts, and protective river improvement and mission overlay districts.

MR9-same location

E10 - relocated

The proposed sign locations will have either no adverse effects or no effects on historic properties. The proposed undertaking will have no adverse effects on 40 sign locations (see table). These are all within one of the four National Register-listed historic districts (Mission Parkway, Lavaca, South Alamo Street-South St. Mary’s Street, or St. John’s Seminary), and one (E5) is also within Mission San Francisco de la Espada, an individually listed National Register property. Seven locations are also within National Historic Landmarks: one (MR5) is within the Mission Concepción, and the remaining six (E1, E2, E4, E5, E6, and Loop1) are within the Espada Aqueduct. Finally, one location (MR5) is also within the San Antonio Missions National Historical Park. The undertaking will have no direct effects, such as ground disturbance, physical alteration, or demolition, to any buildings or structures within these historic properties. The proposed visual elements that will be introduced are of appropriate design, scale, and materials,

and their minimal and sympathetic appearances are too minor to cause indirect or cumulative effects. In addition, the new signs will promote continued use and viability of these historic properties. The proposed undertaking will have no effects on the remaining 10 sign locations where no historic properties are present (see table). No sign location adjustments are recommended, and no further work is recommended for historical resources.

In the table below, a column has been added to the left of the "Sign Designation" column that shows the sign nomenclature in the 100% design plan set. If the location was removed from the plan set, there will be a "Removed" designation. If the location changed names and changed locations, there will be a new label and a "Relocated" designation. If there is no box, then the location and name shown is the same between the 40% plans and 100% plans.

The information submitted for the above-referenced request has been reviewed by the San Antonio Office of Historic Preservation (OHP) staff according to the city's Historic Preservation and Design Section of the Unified Development Code and to address requirements of the Texas Antiquities Code as per agreement with the Texas Historical Commission. The review focused on the possible effects of the proposed project, but more importantly, on the possible effects of any future development of the subject property, on archaeological resources. Disturbance of any site or removal of artifacts from any site within the city without prior review and written clearance by the City Historic Preservation Office (HPO) and/or the State Historic Preservation Office (SHPO) is a violation of the San Antonio Uniform Development Code and/or the Antiquities Code of Texas. Also, if a **federal agency is involved (for example, with funding, licensing, permitting, or oversight) in development or regulation of a property, sites within the property are protected under the National Historic Preservation Act (NHPA)**. Both underground and ground level portions of sites are included as well as sites found after clearance is obtained.

The Texas Sites Atlas indicates that previously recorded archaeological sites are within or nearby the above referenced project area (wayfinding sign locations A3, E6, E10, G1, MCL2, MR27, SM8, and V4). Some of the previously recorded sites are listed on the National Register of Historic Places, listed as State Antiquities Landmarks, or within a National Register District. Wayfinding sign E6 is also within or in close proximity to a historic cemetery. OHP created a map with preferred areas for E6 for consideration (see below). Intact archaeological deposits associated with these sites may be extant and could be significant. Therefore, an archaeological investigation is required.

If a previously unidentified site is encountered during construction work, activities should be immediately stopped in the vicinity and the HPO (210-207-5421) and SHPO notified.

If there are any lands or easements owned or controlled by the State of Texas or any of its political subdivisions within the property, or if there is any **federal agency involvement or jurisdiction relating to the property or its development**, the THC may require other archaeological compliance efforts additional to those required by the HPO. In particular, for historic resources (standing structures), if NHPA compliance is required on this project, a review of these resources and the potential direct and secondary impacts from the project will be needed.



ARCHEOLOGICAL EVALUATION, 2017 BOND PROGRAM, WORLD HERITAGE WAYFINDING–MISSION TRAILS PACKAGE V PROJECT, SAN ANTONIO, TEXAS

Prewitt and Associates, Inc., performed a file search and map review to identify previously recorded archeological sites in and adjacent to each of 50 locations proposed for new or relocated signs to be installed during the 2017 Bond Program project. The objective was to document any archeological sites that could be impacted by the project, and, where impacts are identified, make recommendations for adjusting sign locations to avoid or minimize impacts. The project will involve installing 50 signs with vehicle directional, vehicle logo, and hike-and-bike trail information. The sign locations, all at the edges of existing streets in existing rights of way, are scattered over a distance of about 7.5 miles north-south, with the northernmost one on South St. Mary's Street just north of East Cesar Chavez Boulevard and the southernmost one on Camino Coahuilteca immediately south of Mission San Francisco de la Espada (see map). Final sign designs have not been selected yet, but they likely will consist of metal panels on stone bases standing as much as 11.7 ft tall and impacting areas 7 ft in diameter and up to 3 ft deep below the ground surface (see attached signage option images).

This study consisted of examination of design plans for the project, the Texas Historical Commission's Archeological Sites Atlas, and Google Earth aerial and street views of each sign location. This indicated that none of the proposed sign locations are on known archeological sites (see table), and hence the project will have no effects on them. In fact, 27 are not within 100 m of known sites. Sixteen sites are closer than 100 m to the other 23 locations. Out of the 34 total cases (since some sites are within 100 m of multiple sign locations and vice versa), all but 1 are 5 m away or more. The single sign location closer than this distance (MR18) is at the northwest edge of 41BX12 (Mission Nuestra Señora de la Purísimo Concepción de Acuña). This sign will not impact the site, however, as it is well removed from the main part of the mission complex and will be installed on an existing sidewalk. Of the 16 sites that are within 100 m of sign locations, 3 are listed in the National Register of Historic Places and designated as State Antiquities Landmarks: 41BX4 (Mission San Francisco de la Espada), 41BX12 (Mission Nuestra Señora de la Purísimo Concepción de Acuña), and 41BX1665 (prehistoric and historic [?] Indian camp site).

This evaluation indicates that some of the 50 proposed sign locations are close (within 100 m) to 16 archeological sites, 3 of which are listed in the National Register of Historic Places and designated as State Antiquities Landmarks. None of the signs will be within these sites, however, and their installation will not impact archeological deposits at any of the sites. Hence, the proposed project will have no effects on them. No sign location adjustments are recommended, and no further work is recommended for archeological resources.

In the 100% plans, MR18 is now called MR7, but the location did not change.

In the table below, a column has been added to the left of the "Sign Designation" column that shows the sign nomenclature in the 100% design plan set. If the location was removed from the plan set, there will be a "Removed" designation. If the location changed names and changed locations, there will be a new label and a "Relocated" designation. If there is no box, then the location and name shown is the same between the 40% plans and 100% plans.



LOCATION MAP
















C VEHICULAR TAB CONNECTION SCALE: 3"=1'-0"











A NARROW VEH. DIRECT. SIGN SCALE: 3/8"=1'-0"




B SIGN MOUNTING ON SLIP BASE SCALE: 1"=1'-0"








