**ORDINANCE**

**RESCHEDULING CITY COUNCIL MEETINGS IN OCTOBER, NOVEMBER  
AND DECEMBER 2020, AND JANUARY 2021.**

**WHEREAS**, several City Council members will be attending the Texas Municipal League Annual Conference in October 2020, the National League of Cities Annual Conference in November 2020; and

**WHEREAS**, the City is closed on November 11<sup>th</sup> in observation of Veteran’s Day, and from December 24<sup>th</sup> through January 1 for the Winter Break, and will not resume City Council meetings until the week of January 11<sup>th</sup>; and

**WHEREAS**, it is necessary to reschedule the meetings in October and November 2020 for the dates of TML and NLC, and the meetings occurring on days the City is closed; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The regularly scheduled City Council meetings during the Texas Municipal League Annual Conference in October 2020, the National League of Cities Annual Conference in November 2020, the Veterans’ Day Holiday, the December & January Winter Holiday and the meeting scheduled for January 7<sup>th</sup> are rescheduled as follows:
