## AN ORDINANCE

AUTHORIZING A NEW FREQUENT PARKING PROGRAM IN THE PARKING GARAGE OF THE SAN ANTONIO INTERNATIONAL AIRPORT.

**WHEREAS**, the City of San Antonio is the owner and operator of the San Antonio International Airport and Stinson Municipal Airport, and has authority to promulgate rules and regulations that promote the safe and efficient operation of the airports; and

**WHEREAS,** the rules and regulations, as previously amended through Ordinance 2015-06-18-0550, authorize the implementation of a premium parking program with establishment of a reserved parking area for participants of the program; and

WHEREAS, based on this authority, the Aviation Department implemented a Frequent Parking Program for the San Antonio International Airport Parking Garage effective October 1, 2015 which provides convenient parking in a dedicated corral on the first floor of the garage within walking distance of the terminals for quick access to flights for a monthly rate of \$335.00, based on the daily rate of \$11.00; and

**WHEREAS,** City Council's authorization is required for use of City-owned property permitted under the Frequent Parking Program Terms and Conditions and to amend the parking rates charged at San Antonio International Airport; **NOW THEREFORE:** 

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

**SECTION 1.** The Frequent Parking Program Terms and Conditions set out in Attachment I to this Ordinance are hereby approved.

**SECTION 2:** Funds generated by this Ordinance for registration fees will be deposited into Fund 51001000, Internal Order 233000000010 and General Ledger 4405300.

**SECTION 3:** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

**SECTION 4.** This Ordinance shall take effect immediately upon passage by eight (8) affirmative votes; otherwise it shall be effective ten (10) days after its passage.
