

ORDINANCE 2021-04-29-0278

AUTHORIZING THE ACCEPTANCE OF UP TO \$7,500.00 FROM THE TEXAS DEPARTMENT OF HEALTH AND HUMAN SERVICES FOR A SENIOR CONGREGATE MEAL INITIATIVE GRANT FOR THE PERIOD MAY 1, 2021 THROUGH DECEMBER 31, 2021 AND APPROVING A BUDGET.

WHEREAS, in collaboration with community agencies, the City's congregate Senior Nutrition Program (SNP) provides approximately 3,100 meals daily, Monday through Friday, to seniors 60 years and over at senior nutrition sites; and

WHEREAS, on October 1, 2020, the Texas Department of Health and Human Services invited the City to submit an Innovative Pilot Proposal (Proposal) for up to \$7,500.00 to participate in an initiative to improve the accessibility and utilization of congregate senior nutrition programs; and

WHEREAS, the City Manager's Office approved the submission of a Proposal on January 21, 2021; and

WHEREAS, an initial grant payment of \$5,000.00 would be made in June 2021 and a second payment of \$2,500.00 in December 2021; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The acceptance of up to \$7,500.00 from the Texas Department of Health and Human Services for the Texas Congregate Meal Initiative for the period May 1, 2021 through December 31, 2021, is approved. A copy of the Proposal is on file with DHS.

SECTION 2. The execution of all necessary documents to effectuate acceptance, including acceptance of supplemental grant funds in an amount up to 20% of the total amount initially awarded, is approved.


SECTION 3. Upon acceptance of this award should funding be awarded, new funds and internal order numbers will be created, upon which the amount up to \$7,500.00 will be appropriated in said fund. The budget, which is attached and incorporated here for all purposes as **Attachment I**, is approved and adopted for entry in the City books.

SECTION 4. The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Cost Centers, WBS Elements, Internal Orders, General Ledger Accounts, and Fund Numbers as necessary to carry out the purpose of this Ordinance.
