The City Council convened in a Regular Meeting. The City Clerk conducted the Roll Call as follows:

- 2. Mayor Castro led the Pledge of Allegiance to the Flag of the United States of America.

Councilmember Taylor moved to approve the Minutes for the October 2-3, 2013 City Council Meetings. Councilmember Saldaña seconded the motion.

# POINT OF PERSONAL PRIVILEGE

Councilmember Saldaña recognized members of the National Honor Society and Student Government from Christa McAuliffe Middle School. The students had written letters to Councilmember Saldaña regarding sidewalk improvements needed in the area. Councilmember Saldaña was pleased to report that he had identified funding for same.

Mayor Castro recognized Bonnie Conner and Phil Nelson of the San Antonio Parks Foundation. Mrs. Conner invited everyone to attend the New Year's Eve Celebration that would be held Downtown on December 31, 2013. She thanked everyone that helped make the event successful. Mayor Castro thanked the San Antonio Parks Foundation for their work and stated that he looked forward to the event.

# **ACTION ITEMS FOR STAFF BRIEFING**

The City Clerk read the following caption:

4. A Resolution acknowledging the resignation of Councilmember Carlton Soules, District 10, and initiating procedures to select an interim replacement Councilmember. [Leticia M. Vacek, City Clerk]

City Clerk Leticia M. Vacek presented a Power Point regarding the procedures to select an Interim Replacement Councilmember for District 10. She stated that the Notice of Vacancy would be posted on-line by close of business on Friday, December 20, 2013. She added that the Notice of Vacancy would be published in the Express-News and La Prensa on Sunday, December 22, 2013. She reported that Application Packets to include an Application, Letter of Interest, Resume, and Financial Disclosure Documents would be accepted from January 2, 2014 through 5 pm on Friday, January 15, 2014 in the Office of the City Clerk. She indicated that the documents would be provided to the City Council in preparation for the interviews.

Mrs. Vacek noted that the Mayor and City Council would interview applicants on Wednesday, January 29, 2014 during the B Session and would select up to three finalists to interview the following day. Additionally, at the City Council Meeting of Thursday, January 30, 2014 an appointment would be made by the City Council and that Appointee would be immediately sworn-in. Lastly, a Special Election would be held on Saturday, May 10, 2014 to fill the vacancy.

Mayor Castro reiterated that the District 10 Appointment would be temporary and that a Special Election to fill the remaining Council Term would take place on May 10, 2014.

Councilmember Soules wished everyone a Happy Holiday and stated that he would say goodbye in January.

Councilmember Nirenberg moved to approve the resolution. Councilmember Medina seconded the motion. The motion prevailed by the following vote:

**5.** Staff briefing on the FY 2013 Preliminary Annual Financial Report. [Sheryl Sculley, City Manager]

Maria Villagomez proved the preliminary FY 2013 Year-End Financial Update since Budget Adoption on September 12, 2013. She stated that the figures were unaudited and would change as the Comprehensive Annual Financial Report was finalized. She reported that within the General Fund, additional revenue and less spending resulted in \$13.6 Million, increasing the ending balance for a total of \$21.1 Million reserved to balance the FY 2015 Budget. She highlighted \$7.4 Million net revenues from additional Property Tax, Sales Tax, CPS Energy, Licenses, Permits and User Fees.

Ms. Villagomez stated that challenges still remained for the FY 2015 Budget and that the \$30 Million Financial Gap does not include expenses for the FY 2015 Police and Fire Collective Bargaining Agreement or Civilian Wage Increases. She spoke of the Development Services Fund that ended FY 2013 within budget. She noted that Hotel Occupancy Tax (HOT) Fund Revenue was up \$1.1 Million above projections. She stated that the FY 2013 Airport Fund ended ahead of projections. She added that the Solid Waste Fund ends FY 2013 better than anticipated by \$338,000.

Mayor Castro thanked staff for the presentation and asked if an analysis had been conducted on the SAWS and CPS Energy Revenue to the city. Ms. Villagomez reported that they had included the rate increases in the Proposed Budget and would be presented in the First Quarter Report. Mayor Castro asked of the trend for Property and Sales Taxes. Ms. Villagomez replied that the trend had been positive with both coming in higher than projected.

Councilmember Saldaña asked of the savings in personnel, commodities, and contractual services. Ms. Villagomez replied that they manage vacancies throughout the year and that commodities and contractual services are closed at the end of the Fiscal Year and savings are realized. Councilmember Saldaña asked of the Civilian Wage Increases not included in the FY 2015 Funding Gap. Mrs. Sculley replied that the Step Pay Plan Increases were included but no additional performance pay or cost of living increase was projected.

Councilmember Nirenberg asked of the projections for Medical Increases. Ms. Villagomez replied that the projections include a 7% increase in Medical Costs. Councilmember Nirenberg asked if the impact on savings over the past few months were included in the FY 2015 Forecast. Ms. Villagomez responded that they were not included but would be presented to the City Council during the Mid-Year Report in the Five-Year Forecast. Councilmember Nirenberg stated that he would like to see a recommendation from City Staff regarding the amount of Reserve Funds the city needs.

Councilmember Krier asked if staff would receive input from the Legacy Task Force prior to the FY 2015 Budget Process. Mrs. Sculley replied that would be ideal and hoped the information would be available.

Mayor Castro announced that there were no individuals registered to speak and that no action was required for Item 5.

Mayor Castro called upon the individuals registered to speak.

John Bachman addressed the City Council in opposition to Items 22 and 31. Mr. Bachman stated that that the kennels at Brooks should be closed as they were funded as a temporary measure. He expressed concern with the reduction in the required holding period noting that many constituents have to ride the bus to find their lost pet.

Janice Darling, Executive Director of the Animal Defense League addressed the City Council in support of Items 22 and 31. Ms. Darling stated that reducing the holding period will help animals get adopted sooner.

Rita Braeutigam, Vice-Chair of the Animal Care Services (ACS) Advisory Board, and Mona Thaxton, Chair of the ACS Advisory Board addressed the City Council in support of Items 22 and 31. Ms. Braeutigam stated that they were pleased that the City Council listened to the recommendations of the ACS Board and highlighted the increased Live Release Rate. She noted that the Brooks Kennels had allowed for additional kennel space and the extra 10 months would provide a good exit strategy.

Councilmember Saldaña asked for a summary of the proposed actions. Kathy Davis stated that the 10-Month Lease with Brooks was part of their exit strategy until the new Animal Defense League Kennels are constructed in November 2014. Councilmember Saldaña stated that he was pleased with the increased Live Release Rate and asked of the definition of a quarantined animal. Ms. Davis replied that a quarantined animal would be held in conjunction with a bite case which requires a 10-day observation period to determine whether or not they have rabies. She noted that a quarantined animal could not be adopted.

Mayor Castro thanked ACS Staff for their work to increase the Live Release Rate. He stated that the Brooks Lease would be temporary and that reducing the holding period would free up kennel space and help increase the Live Release Rate.

Councilmember Krier asked of the reduction in the required holding period for pets. Ms. Davis replied that the holding period was three days and did not include the day of impoundment. She explained that it would be reduced to two days for a pet with a Live Outcome. Councilmember Krier requested a summary that could be included in his District Newsletter.

Councilmember Saldaña moved to adopt the proposed ordinances for Items 22 and 31. Councilmember Bernal seconded the motion. The motion prevailed by the following vote:

Councilmember Soules stated that the recommended VIA Applicants were proponents of the Street Car Project and many of his constituents were opposed to the project. He noted that he could not support the appointments.

Mayor Castro thanked the Applicants for volunteering to serve on the VIA Board.

Councilmember Saldaña moved to appoint Gerald Lee, Lou Miller, and Marc Harrison to the VIA Metropolitan Transit Authority as recommended by the Governance Council Committee. Councilmember Medina seconded the motion. The motion prevailed by the following vote:

Councilmember Soules asked of the services that would be provided. Frank Miller stated that they were hiring Jacobsen Daniels Associates to bring their expertise within the Architectural Engineering Component of the Consolidated Rental Car Facility Project. He noted that they would work with the Rental Car Companies to ensure functionality and efficiency of the building. He added that the project was estimated to take three-and-a-half years to complete and Jacobsen Daniels Associates would work with them during that time. Councilmember Soules asked of their role. Mr. Miller replied that they would mediate with the Rental Car Companies and bring information to the Construction Manager at Risk and City Staff. Councilmember Soules asked how much they charge per hour. Mr. Miller responded that they would bill the city on a monthly basis. Mr. Mike Frisbie further explained that the CIMS Department would charge 3-4% for Project Management and would be paid by the Customer Facility Charge (CFC). Councilmember Soules expressed concern that the Rental Car Companies were not contributing and stated that he could not support said item.

Councilmember Krier asked Bill Gold of Enterprise Rent-A-Car if the Rental Car Companies could hire a representative on their own. Mr. Gold replied that was difficult to answer because they did not trust each other and were very competitive. Councilmember Krier asked of the additional public parking that would be built. Mr. Miller replied that two floors of public parking would be built within the new building. Councilmember Krier stated that he felt the city had capable employees to perform negotiation services and could not support the item at this time.

Mayor Castro stated that the concern was that the value of the services of Jacobsen Daniels Associates was not clear and that the \$1 Million cost seemed too expensive. Mr. Miller

stated that they would be working with the city over the next 3.5 years and would help ensure proper design of the facility.

Councilmember Soules asked of the experience in Kansas City. Mr. Miller responded that they had challenges at the end of the project that could have been identified during the design and construction phases. Councilmember Soules noted that Jacobsen Daniels Associates had performed the work at the Kansas City Airport in 2004. Mr. Miller indicated that his discussion with the Kansas City Aviation Director was that they did not have a firm providing the services being requested.

Councilmember Saldaña asked of the burden that would occur if the contract was not approved. Mr. Miller replied that the project would still move forward but it would be difficult for staff to coordinate with nine Rental Car Companies. He spoke of the importance of having a Consultant that understands the Industry and ensure that the project stays on scheduled and budget.

Councilmember Krier expressed concern with the funding rationale noting that the CFC would pay for the Consultant and the parking garage.

Councilmember Bernal clarified that the Consultant would work for the city and that the city does not have the expertise to perform those functions. He added that he understood that it is a large cost but will be paid out over the next 3.5 years.

Councilmember Taylor recommended moving forward with a phased approach which could possibly include the Pre-Design and Design Phases.

Councilmember Soules asked if a Request for Proposals (RFP) had been released. Mr. Miller confirmed that the Rental Car Companies had issued the RFP.

Councilmember Soules moved that said item be presented during a B Session. Councilmember Taylor seconded the motion. The motion prevailed by the following vote:

A. Transportation Update

Mrs. Sculley provided an update on the San Antonio Bike Plan & Implementation Strategy. She reported that the San Antonio Bike Plan was passed by City Council on September 29, 2011 and that the Plan was recognized by the Texas Chapters of the American Planning Association and American Society of Landscape Architects for outstanding professional achievement. She stated that City Staff would present proposed policy recommendations at the February 2014 Infrastructure and Growth Council Committee: 1) Regarding bicycle helmet usage and laws; 2) Vehicular parking on bicycle lanes; 3) Consideration of vehicular lanes during bike facilities implementation; and 4) Considering addition of bicycle traffic and facilities as part of a Traffic Impact Analysis (TIA).
