**AN ORDINANCE**

**AUTHORIZING A FIVE YEAR LEASE AGREEMENT WITH PRIMEFLIGHT AVIATION SERVICES, INC. AT THE SAN ANTONIO INTERNATIONAL AIRPORT.**

**WHEREAS**, Primeflight Aviation Services, Inc. (“Primeflight”) has been a tenant at San Antonio International Airport (“SAT”) since 2011 and wishes to lease space at SAT from which to continue its passenger wheelchair assistance operations for airlines other than Southwest Airlines, Interjet Airlines, and Alaska Airlines; and

**WHEREAS**, Lessee has requested a lease agreement for Room B1A-034 consisting of 272 square feet in Terminal B at SAT; and

**WHEREAS**, Aviation staff has negotiated a five year lease with Primeflight which will generate \$21,906.88 in annual revenue; **NOW THEREFORE**,

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The City Manager or her designee is hereby authorized to execute the Lease Agreement with Primeflight Aviation Services, Inc., a copy of which Lease Agreement is set out in **Exhibit 1**.

**SECTION 2.** Funds generated by this Ordinance will be deposited into Fund 51001000, Internal Order 233000000007 and General Ledger 4409018.

**SECTION 3.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

**SECTION 4.** This Ordinance shall take effect immediately upon receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
