AN ORDINANCE 2013-11-21-0809

APPROVING AN EXTENSION TO THE CONTRACT WITH THE DEARBORN NATIONAL LIFE INSURANCE COMPANY TO PROVIDE GROUP TERM LIFE, ACCIDENTAL DEATH AND DISMEMBERMENT, AND VOLUNTARY TERM LIFE INSURANCE.

WHEREAS, the City's Employee Benefits program provides employees with Group Term Life Insurance, Accidental Death and Dismemberment, and Voluntary Term Life Insurances services; and

WHEREAS, the contract term ends December 31, 2012 and contains two (2), one (1) year extensions; and

WHEREAS, the parties now wish to exercise the second renewal option for a one-year period, beginning January 1, 2014 and ending December 31, 2014; NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or her designee is hereby authorized to execute an Extension to the contract with Dearborn National Life Insurance Company, as set forth in Attachment I. The terms of the Extension are hereby approved.

SECTION 2. Funds are budgeted for this contract in fund 75002000, Cost Center 1002010020, and General Ledger 5201040, as part of the Fiscal Year 2014 Budget.

SECTION 3. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Cost Centers, WBS Elements, Internal Orders, General Ledger Accounts, and Fund Numbers as necessary to carry out the purpose of this Ordinance.

SECTION 4. This ordinance is effective immediately upon passage of eight affirmative votes; otherwise, it is effective ten days after passage.

RENEWAL AND EXTENSION OF PROFESSIONAL SERVICES CONTRACT DEARBORN NATIONAL LIFE INSURANCE COMPANY

This Extension of the CONTRACT is entered into by and between the City of San Antonio (hereinafter referred to as "CITY"), and Dearborn National Life Insurance Company, having its principal place of business at 1020 31st, Downers Grove, Illinois 60515 (hereinafter referred to as "DNL").

WHEREAS, through Ordinance No. 2007-10-04-1044, passed and approved on October 4, 2007, City Council authorized the execution of the PROFESSIONAL SERVICE AGREEMENT (hereinafter the "Council") with DNL to provide Group Term Life, Accidental Death and Dismemberment and Voluntary Term Life Insurance; and

WHEREAS, said Contract provides for an initial 60 month term, expiring on December 31, 2012, with the opportunity to extend for two (2) one (1) year periods; and

WHEREAS, the parties now wish to extend this Contract for the second extension; NOW THEREFORE:

I. Renewal

Pursuant to the provisions of Section VI, Term, of the Contract, CITY and CONTRACTOR mutually agree to renew and extend the term of said Contract for a period of 12 months commencing on January 1, 2014 and terminating December 31, 2014, under the same terms and conditions as stated in said Contract.

If funding for the entire Contract is not appropriated at the time this Contract is entered into, CITY retains the right to terminate this Contract at the expiration of each of CITY'S budget periods, and any subsequent contract period is subject to and contingent upon such appropriation.

H.

All other terms, conditions, covenants and provisions of the Employee Assistance Program Services Contract are hereby renewed and extended.
