The City of San Antonio and the vendor identified above hereby agree to amend the contract identified above, as follows. This amendment is authorized pursuant to the section entitled "Amendments" in 006, General Terms & Conditions of the above referenced contract.

1. AMENDMENTS

1.1 City and Vendor entered into RFO No. 6100003928 pursuant to Texas Local Government Purchasing Cooperative Contract No. 416-12 through the BuyBoard (Original Contract) for uniform rental and laundry services. Contract No. 416-12 expires May 31, 2016. The Texas Local Government Purchasing Cooperative has awarded Vendor a new contract for uniform rental and laundry services, under Contract No. 507-16, which begins June 1, 2016 and terminates May 31, 2017, with two possible one-year renewals. City and Vendor wish to continue to do business without a lapse in service; however, the full extension of the term of this contract, provided for in this amendment, requires approval by the San Antonio City Council.

Therefore, in order to prevent a lapse in service, this amendment shall extend the term of the contract, as herein amended, until City Council considers this amendment, or August 31, 2016, whichever shall occur sooner. Should City Council approve this amendment, then the term of the Original Contract shall be extended to run concurrently with Texas Local Government Purchasing Cooperative Contract No. 507-16, including all renewals and extensions exercised by the Cooperative, unless terminated earlier in accordance with a provision in the Original Contract.

1.2 Contract Reference

All references in the Original Contract to Texas Local Government Purchasing Cooperative Contract No. 416-12 are hereby replaced with Texas Local Government Purchasing Cooperative Contract No. 507-16.

2. PROVISIONS REMAIN IN EFFECT

All other terms, conditions, covenants and provisions of the above referenced contract, as previously amended, not specifically mentioned herein and revised by this document, are retained in their entirety, unchanged, and remain in full force in effect for the duration of said contract, and any renewals thereof.

3. ENTIRE AGREEMENT

This contract, as amended, embodies the complete agreement of the parties hereto with regard to the subject matter contained herein, superseding all oral or written previous and contemporary agreements between the parties relating to matters herein.
